## **BA HONOURS IN ECONOMICS**

The core courses of the Economics Major cover a wide set of areas and provide foundational training in economics. These include courses in Microeconomics, Macroeconomics, International Economics, Statistical and Mathematical Methods for Economics, Econometrics, Development Economics, Indian Economic Issues, and Political Economy.

Additional elective courses focus on specific themes and issues like Indian Economic History or Globalisation, on specialised or applied fields like Public Finance and Money, or on more advanced topics in the core areas.

Students graduating with an Economics Major will acquire an understanding of the discipline and familiarity with economic issues, and also develop their analytical, quantitative, and communication skills. These skills will enable them to pursue further studies, such as Economics and Development Studies, MA programmes and subsequently undertake specialised research.

## **BA HONOURS IN HISTORY**

Courses in the BA Honours in History are structured around a number of themes, areas and time spans. A number of Core Courses, which are compulsory, deal with India from the earliest times to the contemporary period. Indian history is studied in conjunction with other Core Courses that cover world history.

Elective Courses provide opportunities to pursue areas of special interest. These courses are offered on specific themes, societies and nations, for example, art and architecture, decolonisation, wars and revolutions, contemporary India, caste, modernity, science and technology, India and China, Japan, Southeast Asia, Africa, and Europe etc. Issues and questions are framed in historical contexts and critical reading of texts, visual material and artefacts is central to the teaching and learning process.

Students are encouraged to participate in fieldtrips and excursions, and undertake projects that enhance critical thinking and develop analytical skills. In short, they are trained to think and practice as historians. The Programme prepares students to pursue higher studies in History or to choose careers in diverse fields such as administration, law, media, heritage management, conservation, and social/ development sectors. MA in History and some postgraduate programmes in related disciplines are offered at AUD.

# **BA HONOURS IN PSYCHOLOGY**

The Elective Courses are more interdisciplinary and show the applicability of psychological understanding in the areas of counselling, organisational behaviour, education, sexuality, and story-telling traditions.

A dissertation in the final semester is aimed at providing students with a rare opportunity to research an area of their interest.

Graduates with a Major in Psychology from AUD who wish to study further would have the necessary conceptual orientation to do so. In addition, various approaches and skills taught here would enable them to reconsider stereotypical modes of thinking and create an openness to experience. ## **BA HONOURS IN SOCIOLOGY**

With a combination of innovative courses that are theoretical, methodological and topical, the Programme engages students with the history of sociology in India. Taking change, rather than continuity, as their fundamental pivot-point, several courses trace questions of identity and selfhood through various social formations such as neighbourhood, community, village, city, nation and diaspora.

Students will develop practical skills in assessing competing sociological explanations, challenging stereotypical thought, designing research projects and suggesting pathways for bringing change in the real world.

Sound training in the discipline and a good grasp of interdisciplinary scholarship, enable students to pursue higher studies in related fields in the social sciences – Sociology, Gender Studies, Development Studies, Economics or Political Science.

Graduates will be well placed to enter graduate

programmes or take up employment in affiliated professional fields such as media and journalism, business and management or urban planning. Alternatively, they will be equipped for a career in the non-government sector, the media and the Government.



# SCHOOL OF DEVELOPMENT STUDIES (SDS)

The two-year MA Programme in SDS equips students with the ability to address the challenges of development and public policy as they affect developing societies. This inter-disciplinary Programme is based on the foundations provided by the disciplines of Sociology, Political Science and Economics.

It is taught and guided by faculty from a whole range of disciplines and specialisations in the social sciences. It introduces students to the rich theoretical foundations of the debates on development and will be based on experiences from across developing countries, especially India.

A strong grounding in research methodology along with emphasis on field-based learning enables students to research concrete problems faced by developing countries. The curriculum combines innovative classroom learning with seminars, group work, projects, and a compulsory internship and dissertation. More than 30 percent of the learning is structured outside the formal classroom process.

In order to continuously provide the best in the discipline, the course committee will institutionalise mechanisms for collecting feedback on the curriculum from experts in this field as well as from potential employers.

# **PROGRAMME STRUCTURE**

Teaching will be done through class lectures, workshops, seminars and field projects. The programme emphasises research and analytical skills, oral and written communication, and exposure to development practice. A strong component on research methodology will comprise courses in basic research skills, quantitative and qualitative techniques, social science research and participatory rural appraisal.

Each 16-week, 4-credit course is structured around a range of topics (or modules) that will be taught in 4 hours each week. 2-credit courses are taught in modules of 2 hours each week for 12 weeks, or for 4 hours per week for 6 weeks. Study modules are a combination of lectures, student presentations and class discussions. Students are expected to read up 50-100 pages for each module. Guest faculty are frequently invited to teach to supplement the knowledge and expertise available within the School and provide exposure to the world of practice. Faculty of SDS will be actively involved in mentoring and guiding students for internships, supervision of dissertations and dealing with problems that students face during course work. The teaching schedule will include specified hours for student-teacher interaction outside of classroom hours including tutorials. Weaknesses in writing ability and communication among first-year students will be dealt with by giving opportunities for re-submission of assignments/ papers (subject to course deadlines). In addition, several field trips will be organised that involve close interaction with and teaching of students in a non-classroom environment.

# SCHOOL OF EDUCATION STUDIES (SES)

SES is envisioned to evolve as a community of professionals and scholars endeavouring to understand education in its historical and contemporary contexts through engaged scholarship and practice. The School aims to bridge the gap between the theory and practice of education in its multiple locations; and attempts to foster greater convergence between the study of education as a social phenomenon and the preparation of professional educators.

In this context, the School has been working towards the development of a rigorous praxis-based theoretical perspective for analysis and research while engaging with teacher education, pedagogy, curricula, policy, planning and administration.

MA in Early Childhood Care and Education, which is being offered in collaboration with CECED in AUD, is envisioned to be in consonance with this vision of SES. It will, in addition, bring to the Programme, a policy research and advocacy perspective in ECCE in the Indian context.

CECED in AUD has been functioning since 2009 as a resource centre with focus on evidence based advocacy, quality promotion, and capacity building in ECCE. Its mission is to contribute towards the national goals of social justice and equity by promoting developmentally and contextually appropriate Early Childhood Education and Development (ECED) as every child's right to a sound foundation, and to raise ECED to the forefront of policy formulation, and effective and universal programme implementation. Its aim is to serve as a single window to ECED by being:

• a hub for documentation, knowledge creation and theory building through longitudinal, multidisciplinary and multi-centric research and documentation along with its dissemination,

• a technical resource for the promotion of quality and related capacity building for policy makers, professionals, practitioners, parents and the community; and

• a clearing-house and a repository of information/ data on ECED.

# MA (EARLY CHILDHOOD CARE AND EDUCATION) PROGRAMME

MA ECCE is proposed as a two-year Programme with an exit option after the first year, leading to a PG Diploma in ECCE.

The PG Diploma courses have been conceptualised with the aim of supporting professional upgradation of the quality of planning, supervision and management of ECCE programmes for young children. MA ECCE courses move beyond the simple Diploma courses towards a more in-depth and scholarly understanding of ECCE as a discipline anchored in interdisciplinary engagement including child development, sociology, history, critical pedagogy, psychoanalytic frame, anthropology, and management.

# SCHOOL OF LIBERAL STUDIES (SLS)

SLS offers a range of interdisciplinary and overlapping programmes that support, encourage and redefine liberal arts education through cutting-edge interdisciplinary courses, interactive pedagogy and learning that goes beyond classroom spaces.

## **PROGRAMME DESCRIPTION**

MA in Economics provides students with a rigorous and in-depth advanced training in economic analysis with particular emphasis on equipping them with the ability to comprehend and think about contemporary economic issues, including the challenges confronting developing countries like India. It will equip students for careers in government agencies, the corporate and financial sectors, development organisations, the media, and also in academia (including further studies).

The Programme draws on different theoretical perspectives and traditions, within and outside the discipline, on contemporary social phenomenon; and uses creative pedagogical approaches to offer a well-rounded training that would enable students to achieve a variety of objectives – develop a socio-political and historical perspective on the economy and the discipline which analyses it, master the quantitative techniques which are used extensively in economic analysis, understand and learn to analyse contemporary economic issues at the global and national levels, and acquire skills for absorbing and communicating economic ideas on the 'social' – which also reflect the University's vision.

The first two semesters focus on the Core Courses which provide a mix of economic theory, quantitative techniques, economic history, and analysis of concrete development problems with a component focused specifically on India. In the third and the fourth semesters, the mix of Core and Elective Courses build on these foundations to complement interdisciplinary perspectives and enable students to develop an element of specialisation in their preferred areas.

# **DESCRIPTION OF CORE COURSES**

**Macroeconomics I and II** cover the evolution of the main body of macroeconomic theories with reference to a developed capitalist economy and its changing context with a focus on the macroeconomics of developing countries like India.

**Microeconomics I and II** cover theories of utility, production and cost, and strategies of firms under perfect and imperfect competition along with general equilibrium models and social welfare.

Statistics and Data Exploration focuses on empirical investigation of relationships using different frameworks and methods, and various computer skills. The course will equip students with quantitative skills for analysis of both primary and secondary data and show how to apply them to real world data.

International Trade and Capital Flows examines the significant contemporary features of international economic relations placed within a broader historical and theoretical context by focussing on trade and finance. It shall cover different theories of international trade, balance of payments and capital flows, and the political economy of external sector policies within various historical perspectives.

Theories of Value and Distribution explores the divide between Classical and Neoclassical theories of value and distribution. These schools and the associated theories will be discussed in the contexts in which they emerged and developed, the differences in their premises and the fundamental questions they are designed to answer, and their critiques.

**Development Economics** focuses on contemporary challenges facing developing countries in the age of globalisation through a comprehensive discussion of Third World development since the mid-twentieth century, and the continuities and changes in their situations.

Capitalism, Colonialism and Development explores the political economy of development and underdevelopment in

relation to the role of colonialism in the history of capitalism, with particular reference to the study of British and Indian economic histories during the period of colonialism in a unified framework.

Indian Economy examines the historical evolution and contemporary situation of a variety of issues arising in the process of the attempted transformation of India's low-income agriculture-dominated economy after Independence. Problems of industrial development and the role of services, the agrarian situation, employment, poverty and inequality, etc. shall be discussed in the changing economic policy context.

Elective Courses may be opted from those offered by the programme faculty in such areas as advanced quantitative techniques; advanced economic theory & general equilibrium analysis; monetary economics, public finance; economics of the financial sector; industrial organisation; agricultural economics, growth & dynamics; development & the Indian economy; economic history, history of economic thought & political economy; energy, natural resources & environmental economics; ecological economics; labour economics; economics of gender, economics of institutions, economics of marginalisation & discrimination, research methods, etc. MA Economics students may also complete under the category 'Electives', courses from other Schools. Master's students of other AUD programmes may likewise enrol for MA Economics Electives and for MA Economics Core Courses (with permission of the Economics programme faculty).

Support Modules in Quantitative Analysis and Research Skills Development are credited and non-credited modules delivered through workshops over the course of the MA programme to equip students with academic skills for developing quantitative analytical capability, writing skills and effective use of library and computing resources.

# **PROGRAMME STRUCTURE**

# **PROGRAMME DESCRIPTION**

The MA Programme in English proposes to dismantle the hierarchy between British Literature and other literatures in English, including literatures in translation. It seeks to bring into focus the significance of literatures belonging to lesser known languages and regions. Strengthening the overall vision of Ambedkar University, this Programme hopes to orient students towards engaged and reflective scholarship. A concern with social and literary margins will consistently guide the Programme's overall vision, philosophy and content. It is envisaged that through this Programme students will develop a critical sensibility towards the larger politics of culture, society and state so that they actively and artistically interrogate and intervene within the givens of the hegemonic political and cultural order.

It integrates interdisciplinary paradigms to facilitate a greater amalgamation between various literatures, theory and practice, on the one hand, and between music, dance, theatre, cinema, literature and visual arts, on the other. Students will be offered a wide range of inter-disciplinary courses which will help them situate literature in the context of other disciplines.

# **COURSE DESIGN AND EVALUATION**

The MA Programme in English comprises 16 courses of 4 credits each, amounting to a total of 64 credits. Each course is of a semester's duration. Every semester, students have to choose 4 out of the 7 courses on offer.

In keeping with AUD's emphasis on inter-disciplinary studies, students will be encouraged to opt for courses from other Programmes within the School of Liberal Studies or from any other School of the University amounting to a maximum of 16 credits.

Assessment will be conducted through term papers, class presentations, discussions, and participation along with workshops, group work, tests and other assignments.

AMBEDKAR UNIVERSITY DELHI (AUD) LOTHIAN ROAD, KASHMERE GATE, DELHI 110 006 Students will be provided with a detailed reading list for each course. They are expected to attend classes regularly and participate in discussions and other official course/ programme activities.

Students are not required to take courses in any particular order and there are no 'compulsory' courses upon which programme completion depends.

Areas of Study for the Current English Programme:

Literatures of North America and the British Isles, Forms in Literature, Literature and the other Arts, Themes in Literature, Colonial and Postcolonial Literatures, World Literature in Translation, Literary and Cultural Theory, English Language Education, Translation: Theory and Practice, Oral, Indigenous and the Folk Imagination, and Literatures of the Indian Sub-continent.



## MONSOON SEMESTER COURSES

Short Story: It focuses on the short story, a form which despite having very ancient roots, has gained a formal acknowledgement fairly recently. It focuses on the rise and development of the short story in the nineteenth century in America, Russia, Germany, Britain and France.

Shakespeare's Many Adaptations: It will look into four of the most widely read plays written by William Shakespeare (Othello, Hamlet, Macbeth and King Lear) and how they have been adapted for the screen across cultures, languages and cinematic imaginations.

Contemporary Indian English Fiction: It will briefly review the history of Indian English fiction tracing it from its colonial origins to the latest trends, and how it paints the larger picture of India. Themes of nation, culture, politics, identity and gender will be taken up for in-depth analysis and discussions through representative texts.

Post-colonial Theory and Practice: It aims to introduce students to some of the major issues and themes of postcolonial theory and will revolve around the themes of colonialism, imperialism, language, hybridity and mimicry, cultural identity, diaspora, representation, resistance and de-colonisation.

Lost Generation: American Literature between the World Wars: The literature written between the two World Wars reflects the conflicts and confusions that formed modern America. The course through a detailed reading of some of these texts will attempt to understand the difficult coming-of-age of the American nation.

Analysing Fiction: The Human Condition: This course looks at specific works of fiction that reflect the various facets of the human condition. The course observes the psychic and existential journeys of individuals as they face up to their own inner being and also realise the multifaceted realities of human existence.

Understanding Poetry: Form, Thought, and Experience: It attempts to understand poetry across ages, categories, forms, styles, movements, and milieu. It also attempts to engage students with critical thought on poetry and the processes involved therein. Through a detailed reading of the works of select poets across the globe, various dimensions of the art of poetry would be explored.

# SCHOOL OF HUMAN ECOLOGY (SHE)

SHE aims to develop a deep and multifaceted understanding of environmental concerns that includes perspectives from the social and the natural sciences. The School expects its students to graduate with the knowledge and skills necessary to analyse and address environmental concerns keeping in mind social equity, academic rigour and ecological sustainability. SHE promotes field-based teaching and field research, which connects the theory with praxis.

# MA ENVIRONMENT AND DEVELOPMENT

The goal of the MAED is to foster interdisciplinary learning issues at the intersection of human society and the biophysical environment with a perspective grounded in the experiences of the Global South. It is unique in India given its orientation and scope, which is guided by the idea that ecological challenges such as atmospheric pollution, resource depletion, and the attendant threats to ecosystems and biodiversity, result from a complex interaction of socio-political and biophysical factors.

# PROGRAMME CONTENT AND DELIVERY

MAED comprises 64 credits spread over two years (4 semesters).

Each semester is of 16 credits carried out over 16 weeks of academic work including assessments and field projects.

The 64 credits required for completion of the Programme are distributed as: 8 Core Courses (4 credit each, totalling 32 credits); Specialised Electives (2 or 4 credits each, totalling 22 credits), Internship (2 credits) and Dissertation (8 credits).

Each credit in a course is equated to one hour of teaching or two hours of group work/ laboratory work/ field work, every week for 16 weeks. Thus, a 4-credit course typically entails four hours per week of in-class interaction.

## SEMESTER-WISE ALLOCATION

The I semester provides an introduction to basic concepts in ecology, development, the histories of environment, and research methods. The II semester continues to focus on research tools, knowledge and skills from diverse areas. The second year (III and IV semesters) provides students the opportunity to pursue specific topics in particular aspects of environment and development.

# ATTENDANCE, ASSESSMENT AND EVALUATION

Students will be evaluated and graded on the basis of a variety of assessment situations including class participation and discussion, presentations, written tests/ examinations, take-home assignments, field-based projects and term papers. The mode of assessment and its patterns may differ from course to course. The purpose of assessment and evaluation at SHE is to facilitate and promote learning with understanding and hands-on exposure. Students are expected to be regular in attending classes, workshops and other educational exercises as assessments will be continuously held throughout the semester.

## LEARNING-TEACHING METHODOLOGY

Teaching is done through a combination of class lectures, workshops, seminars and field projects with an emphasis on analytical skills, oral and written communication, and practical exposure.

# FIELD PRACTICUM SUMMER INTERNSHIP (2 CREDITS)

The internship will be scheduled in the summers, between Semesters II and III for 4-6 weeks to bridge theory and praxis. Each student will be attached to an organisation (non-governmental organisation, research institution, consultancy firm, etc.) or to faculty at the University.

# **DISSERTATION (8 CREDITS)**

Students will take up a research project under a designated faculty supervisor at the end of Semester III, which will lead to a dissertation. Assessment is based on a presentation and a written dissertation.

# CAREER OPTIONS

It is hoped that graduates of MAED will be suitably equipped to work in government agencies, academia, non-governmental organisations, consultancy firms, civil society initiatives, and the media.

# SCHOOL OF CULTURE AND CREATIVE EXPRESSIONS (SCCE)

SCCE is visualised as a location that implements a new vision of art pedagogy and practice in the country. The School will provide a nurturing ground for the development of new and different art making practices and theoretical insights across the areas of Visual Art, Literary Art, Performance Art and Cinematic Art.

# INTRODUCTION

It is internationally recognised that India is one of the largest producers of a variety of narrative films in more than one location in the country. Indian mainstream cinema is also known for its specific narrative features and its central place in the social life of the country, particularly through its song and dance sequences and melodramatic appeal. In contradistinction to the mainstream cinema a significant group of alternative film makers too have grasped the attention of the world beginning with the inimitable figure of Satyajit Ray. In spite of this extraordinary creative output the specific tasks of studying film making and viewing practices as well as the task of critical and analytical approaches to film texts have not been sufficiently addressed by Indian academia. Even though scholarly attention was beginning to be drawn to cinema since the early eighties, the MA Film Studies Programme in the SCCE is among the very few of its kind in the country.

It tries to address the task of studying cinema in India in all its varieties in a global comparativist mode without subscribing to any pre-set hierarchy of aesthetic merits and artistic excellence. It seeks to bridge the gap between a philosophical understanding of film as an art form and the cultural studies understanding of its role as mass media drawing on the rich theoretical legacies of Benjamin, Kracauer and Deleuze among others. Particular attention is paid to the multi-sited film production in India not allowing the undue attention paid to Bollywood to eclipse the pluralisation of film cultures in India. The Programme is equally interested in fostering historical, anthropological and textual analysis of cinema paying close attention to its embedded nature in the social and political history of the country.

# THE NATURE AND CONTENT OF THE COURSES

The Foundation Courses common to all students in the School provide them with exposure to key texts in Critical Theory and Cultural Studies. The Elective Courses offered explore interdisciplinary grounds of all the 4 programmes.

Core Courses in Film Studies provide students with knowledge of the evolution of cinema as an art form in the beginning of the twentieth century, train them in close analysis of film narratives, give them an in-depth knowledge of multiple strands in film theory, give exposure to significant aspects of various kinds of film-making practices in India in terms of regions, genre and aesthetic frameworks. They are also equipped through the courses to analyse cinema as part of popular culture, mass media and ideological apparati.

The Programme is of 2-years duration with 2 semesters, Monsoon and Winter, in each year. A semester is 16 weeks long. A Course meeting for 4 credit hours a week for the duration of a semester enables students to earn 4 credits. Students should register for a minimum of 16 credits each term and need to earn 64 credits to complete the programme successfully. They may register for more credits on payment of extra fees.

All students of SCCE in the 4 MA programmes offered need to take three common Foundational Courses, one each in the first three semesters, for 12 credits in all. In the spirit of fostering interdisciplinary learning they are encouraged to take 4 Elective Courses offered by the School or any other School in the University, one each in all the 4 semesters, for 16 credits in total. They need to take 7 compulsory Core Courses pertaining to their respective cliscipline for 28 credits in total. Their MA D.sertation work in the final semester will earn them 8 credits.

# PROGRAMME REQUIREMENTS

Each course has its specific set of requirements which are spelt out during the orientation programme where the courses are presented. The requirements may consist of regular attendance and classroom participation, written assignments of different lengths, classroom presentations, take-home exams, diarised observations and so on. There are no term-end exams written without books under supervision.

The completion of the programme successfully and meritoriously will depend on the completion of the required number of courses, voluntary participation in all activities of the School, writing and presenting a dissertation at the end of the second year.



The Film Studies Programme is designed to enable student to both creatively and critically engage with the art of film narrative. Based on the inclination of the individual student it may launch the person in their engagement with cinema and other visual narrative forms as critics or creators. Though an MA in Film Studies is not directly related to employment, a student may demonstrate his/her awareness of the intricacies of the art to secure placement in the entertainment industry, the television industry, various sites of film making, work as a film journalist or critic in the press and other media. A student may also proceed to be a researcher and/or an academic in related fields.

# SCHOOL OF HUMAN STUDIES (SHS)

SHS has brought together psychologists, social anthropologists, sociologists, philosophers and social work professionals to offer two interdisciplinary programmes: MA in Psychology and MA in Gender Studies, both drawing strongly not only from intellectual sources but also engaging with the real life 'situatedness' of a variety of subjectivities around us.

It is an interdisciplinary space for thinking and reflecting on myriad meanings of being human.

The Programmes focus as much on the promise and potential of the human, as on the actual historical exclusions and marginalisations, characteristics of human cultures.

# **MA GENDER STUDIES**

The Programme is an integral part of the interdisciplinary intersectional and dynamic vision of AUD, which conceives of academic learning as providing students with a critical conceptual framework in its engagement with social realities and issues.

Consistent with this ideal, the MA Programme is envisaged as a thoroughly interdisciplinary one, drawing upon gendered analyses from the sciences, social sciences and the humanities.

# **TEACHING METHODOLOGY**

The pedagogies of teaching and learning employed at Gender Studies are intended to inculcate a feminist sensibility in our students, in ways that balance academic rigour with intellectual freedom. We encourage them to experience the personal as political by bringing into the classroom spaces, critical reflection on their own and others' life histories and activism in conjunction with feminist texts and theorisation and offer multiple sites of assessment.

# **CREDIT SYSTEM**

The MA in Gender Studies is a 64 credits programme. Core areas like South Asia and Global Feminisms offer both a historical and methodological analysis of the movements around gender and women. Elective options build on faculty specialisations to encourage students to take up specialisations both amenable to employability and furthering the key research agenda of the field. The students also have the freedom of being able to choose Electives across the different Schools and Programmes of the University, which adds to the depth of varied perspectives that they bring to the Gender Studies courses.

### INTERNSHIP

Certain structural innovations in the Programme like the requirement of doing an internship enables students to work with an organisation, and ensures that even while studying, the student is able to make links with the outside world in terms of experience and creating opportunities for future collaborations.

# DISSERTATION

The dissertation in the final semester of the MA is an opportunity not only to contribute to knowledge production in the field of Gender and Women's Studies but also to interpret and challenge existing knowledge systems from a gender-sensitive lens. The research thus conducted is also expected to help students in identifying the potential areas of research and work to be taken up after the completion of the Programme.

# **MA HISTORY**

The MA History Programme is designed to impart understanding of historical phenomena and processes, as well as to transmit skills of historical analysis, and encourage the historical imagination. The Programme teaches students to inquire historically while making use of insights and interpretive techniques of other disciplines, and it seeks to encourage a spirit of critical thinking about contemporary social questions. Skills acquired through the Programme shall serve programme graduates well, not only in academe but in such careers as journalism, publishing, educational administration, museumship/ archival management, tourism/heritage management and government service (among others).

16 credits are allotted to four Core Courses (each of 4 credits). These are compulsory for all MA History students.

# **PROGRAMME STRUCTURE**

Elective History Courses (4 credits each) are grouped in two broad categories: South Asian History and Comparative history. Courses in the former are unified with respect to their geographical dimension — areas and regions within or across the Indian subcontinent — and address various themes. Courses in the latter are designed to acquaint students with the eclectic nature of historical research while encouraging them to reflect upon connections between 'Indian History' and other fields of history. Students must complete at least 8 credits and up to 32 credits of Elective Courses in each of these two categories. Courses offered from each category may change from year to year.

AUD is committed to interdisciplinary learning, recognising that students experience intellectual enrichment when they are exposed to more than one knowledge area or 'discipline'. MA History students are encouraged but not required to complete up to 8 credits of non-History courses either from SLS or other Schools of the University.

Each MA History student is required to complete a significant research project amounting to 8 credits during the fourth semester (they undertake two 'taught' courses during the same semester). Students engage in extensive and intensive review of secondary sources and/or conduct research with historical data (primary documents/source materials). 'Research Paper' courses shall involve faculty guidance but little classroom instruction. Certain required activities for this exercise shall commence in the III semester, even though grades and credits for them will be awarded only in the IV semester. The Research Paper is expected to be of 5,000 -8,000 words, including notes and bibliography, and may involve use of non-English as well as English language sources, and could involve oral interviews or other non-written sources. Each student's research shall be evaluated by a group of faculty members culminating in a viva voce exam attended by other students.

Whereas the passing grade for every 'taught' course (whether core or elective) is C+ (C PLUS), students must achieve a minimum grade of B- (B MINUS) in the Research Paper course. Students not meeting this standard shall revise and resubmit their Research Papers. The 4 Core Courses must be completed in the sequence in which they are offered. Most of the core courses are team taught. MHC01 and MHC04 are Semester I courses, MHC02 is a Semester II course, and MHC03 is a Semester III course.

MHC01: The State in Indian History. The course focuses on the important institution called the State. Students examine processes of state formation, ideas and institutions of the state and the different types of state-systems that have emerged in the Indian subcontinent from c. 1000 BCE to the present time.

MHC02: The Making of the Modern World. The course examines a period that witnessed unprecedented movement of people, things and ideas, literally creating what we now refer to redundantly as the 'globalised world'. Modernities and modernisation are focal points of the course.

MHC03: Power, Culture and Marginality in India. This course familiarises students with the key concepts of power, culture and marginality and their relations to historical processes, patterns and structures in India. The course traces the emergence, perpetuation and dissolution of identities and examines the social conflicts or tensions contained within (and spilling out of) the identities.

MHC04: Problems of Historical Knowledge. Can we have historical understanding without a philosophy of history? This course focuses on questions and problems involved in historical research and writing and familiarises students with key ideas of modern philosophy that have influenced the development of the social sciences in general and history in particular over the past two hundred years.

# SCHOOL OF CULTURE AND CREATIVE EXPRESSIONS (SCCE)

SCCE is visualised as a location that implements a new vision of art pedagogy and practice in the country. The School will provide a nurturing ground for the development of new and different art making practices and theoretical insights across the areas of Visual Art, Literary Art, Performance Art and Cinematic Art.

# INTRODUCTION

The Programme has pioneered the pedagogy of creative writing in India. It is unmatched by older schools in the US because of its unique insistence on inculcating in the student both the practice and the theory of literary writing. It imagines the writer as inhabiting a range of historical, social and existential horizons, each of which have their bearing on the nature and depth of individual literary output. Rather than simply equip students already fluent in English with a set of supplementary skills, it teaches them to acquaint themselves with the literary idioms of the many languages of the sub-continent and of Europe.

It encourages them to grapple with some of the most radical theses on the modern as they have been developed for instance by such thinkers as Foucault and Benjamin on the one hand, and Gandhi and Ambedkar on the other. It asks them to take seriously the political and personal stakes involved in the struggles around indigenous lands, sexuality, caste and gender. The Programme understands literary writing as the patterning of life after thought and as such it places the greatest emphasis on writing that is philosophically informed. To this end, the Programme is keen on fostering generic innovation as students write in a way that traverses genres, media (dance, film, theatre, the visual arts) and historical and geographic boundaries. They must, at the same time, develop an ability to reflect essayistically on the nature

# THE NATURE AND CONTENT OF THE COURSES

The Foundation Courses common to all students in the School provide them with exposure to key texts in Critical Theory and Cultural Studies. The Elective Courses offered explore interdisciplinary grounds of all the 4 programmes.

Core Courses in Literary Arts entail an apprenticeship in both the theory and practice of literature, in equal part. Students are encouraged to gain an insight into the nature of generic invention, the range of generic possibilities (novel, short story, poem, essays and other genres such as travelogue), the politics of literary history and canonisation, the pressing needs of the new comparative literature involving literary traditions outside the Euro-American orbit, and the relation between the history of literary theory and the history of philosophy (the latter includes the history of aesthetic theory).

# **PROGRAMME** REQUIREMENTS

Each course has its specific set of requirements which are spelt out during the orientation programme where the courses are presented. The requirements may consist of regular attendance and classroom participation, written assignments of different lengths, classroom presentations and intensive discussions of literary output (especially in the writing practicum), take-home exams, diarised observations and so on. There are no term-end exams written without books or under supervision; the final assignment is typically in the form of a required term paper. The completion of the Programme successfully and meritoriously will depend on the completion of the required number of courses, voluntary participation in all activities of the School, writing and presenting a dissertation at the end of the second year.



The Programme seeks to develop the profile of the writer as a committed intellectual well versed in the literary and aesthetic movements of the modern period; such a writer cannot be unaware of the literary history of the medieval and ancient epochs both of Asia (especially India) and the West: nor can such a writer remain aloof from the key political and social issues of our times. Such an apprenticement in the life of the mind is by no means a guarantee of employment. Nonetheless, to the extent that such training fosters a zeal for reading widely (the capacity for unstinting erudition) and a capacity for thought that is both historically self-reflexive and philosophically radical, to that very extent will the Literary Art Programme minimally imprint on a students' literary oeuvre the mark of originality. The latter may well find favour in the field of literary journalism, publishing, new media and advertising.

# INTRODUCTION

Culture and its products are being globalied in this age. Thus to study the culture in transition and to reconnect it with society, Performance Studies has been established as a discipline in many renowned universities. Students can develop a unique critical thinking and can also implement it in their practice. MA in Performance Studies at AUD is a unique programme and the first of its kind in India.

"Performance Studies" is an interdisciplinary field of research that draws on the social sciences, the humanities, art and theatre. It focuses on the pervasiveness of performance as a central element of social and cultural life, including not only theatre and dance but also such forms as rituals and practices of everyday life, avant-garde performance art, popular entertainment, sports, political demonstrations and potentially any instance of expressive behaviour or cultural enactment. Thus, MA Performance Studies aims to contribute to the development of engaged scholarship in the field with a unique perspective given the rich and varied experience situated in and informed by the culture and heritage of India.

# THE NATURE AND CONTENT OF THE COURSES

The Core Courses draw upon Theories of Performance, which provides an overview of various theories of performance, both modern and pre-modern and across the globe. It places emphasis on the theoretical developments in contemporary times especially in the context of inter-/multi-disciplinary approaches such as the Avant Garde, Post Dramatic, Digital and Internet Performances. History/Historiography of Performance, envisaged as an attempt to look at the history of performance breaking away from the linear model of historical studies. Performance and the Social, which attempts to broaden the ambit of performance in a conceptual and philosophical manner by redefining the relationship between performance and the social (performance as social and vice versa). Performance as Research, conceptualises performance as research in itself rather than separating and focusing on research as a background of/backdrop to performance practices. Reading/Decoding Performance imparts tools to critically review and interpret various kinds of performance. Apart from these Core Courses, there is a pool of **Elective Courses** which are historical, conceptual and practical in nature. Some of these are Space and Spectatorship, Body in Performance, Performance in the Digital Age and Devised Performance.

The Foundation Courses are common to all students of the School that provide them with exposure to key texts in **Critical Theory and Cultural Studies.**

# DURATION AND COURSE STRUCTURE

# SCHOOL OF HUMAN STUDIES (SHS)

School of Human Studies is an explorative, interdisciplinary space for thinking and reflecting on the myriad meanings of being human. Academic programmes housed in the School focus on the promise and potential of the human along with the actual historical exclusions and marginalisations that humans have led to.

# MA PSYCHOLOGY

The MA Psychology (Psychosocial Clinical Studies) is an innovative program which attempts to inculcate in students a capacity for clinical and critical thinking that will facilitate a nuanced sensitivity to diverse states of emotional experience, a regard for the margins of Indian society and a capacity to theorise the same. It may be thought of as a first attempt in India to redefine and provide a new direction to the disciplinary orientation of Psychology.

We expect our students to engage effectively in academic and research fields. It is hoped that our focus on clinical thinking and related processes will enable our students to effectively respond and work in contexts, such as counselling and psychotherapy, which require engagement with the nuances of feeling states and the richness of human subjectivity.

The Program has a strong interdisciplinary framework and draws from relevant and rich literature in Psychology, Psychoanalysis, Clinical Thinking, Feminist Scholarship, Philosophy, Cultural and Linguistic Anthropology, Spiritual Studies, Sociology, Literature, Art and Aesthetics etc. The Foundational Courses, which are interdisciplinary in nature, generate an engagement with the multiple understandings of the term human. Students of the Programme needs to be thoroughly familiar with intra-psychic and interpersonal processes; and at the same time, while working with experience, they need to be informed of the socio-cultural and political processes that both constitute these and differentially enable a living of these experiences.

# **PROGRAMME OBJECTIVES**

Recognise the complexity in inner worlds and explore forbidden realms in thoughts and feelings

Experience psyche as a source of inner freedom and aspire towards playfulness, and creative action

Appreciate psyche as created and formed by the matrix of social, political and historical forces

Appreciate difference and plurality in life while critically understanding the dynamic processes that foster marginalisation and exclusion.

# FEATURES OF THE PROGRAMME

#### Summer Fieldwork

During the summer break intensive fieldwork is initiated for a period of 30 days. Students are assisted in placement in institutions such as hospitals and NGOs engaged in the field of mental health and trauma. They work with people affected by violence and participate in processes of restoration and rehabilitation. The internship is a site where students engage and develop a relational and clinical acumen. Also, students can make visits to places where indigenous processes of healing happen and document their observations. Regular supervision is provided during this period. A detailed report documenting experiences is required at the end of the internship.

Research Project/ Dissertation: As a part of fulfilling their requirements towards completion of the MA Programme, students in their final year are required to draft a research proposal and complete a dissertation on an appropriate topic in consultation with their assigned supervisors in the faculty.

#### Mentorship

A special feature of the Programme is mentorship where a group of 6-7 students of the class work closely with a single faculty for 2 years. It is a group process where a nurturant relationship develops between the mentor and the mentee, and students can articulate their anxieties and reflect on their subjective experiences that are evoked in the class. This is also a space where personalised feedback and reflection on assessment and grades may be given.

Furthermore, mentorship groups are powerful locales for peer learning and exchanges in a close engaged ongoing intimacy. The co-constructed nature of knowledge, and the inter-subjective sense of the self, both make themselves available in a small group setting.

#### Pedagogy

The Programme uses many innovative teaching methods and styles such as seminars, workshops, film analyses, case studies, clinical vignettes, literacy narratives and role playing. The teaching style is immersive, reflective, and ideally a reflexive exercise.

#### Assessment and Evaluation

The assessment procedure for the Programme comprises a variety of assessment situations, spanning the entire duration of the semester. The assessment situations range from exams, open book tests, viva-voce, group presentations, film analyses, take home assignments, term papers and peer assessments. An effort is made to capture the myriad capacities of the student – from comprehension and writing, connecting the psyche with emotional struggles of significant others, acquiring clinical sensitivities and skills, and testing their relevance in work contexts.

# **CAREER OPTIONS**

The graduates may go into further training and/ or professional streams as future Psychotherapists, psychological thinkers and critical researchers. They may also be fruitfully employed in NGOs working with issues related to Mental Health and Gender or related concerns in the clinico-social domain, or as counsellors in schools and other educational institutions, consultants in prisons and half-way homes.

# SCHOOL OF DESIGN (SDes)

SDes is unique in its conception. It draws from its distinct position within AUD, a university wholly focussed on the humanities and social sciences, to amalgamate core attributes of design with human needs in their complex social settings. By relocating the hitherto object-centred focus of design to that of the "social", SDes proposes to create equitable, just and sustainable communities through new products, services, systems, interfaces and imaginations.

It also attempts to re-visualise design education and practice in order to creatively meet the multiple challenges offered by a rapidly changing, deeply interconnected local and global landscape.

We see this as an opportunity to question existing specialisations, examine current curricular structures and pedagogies around the world and contemplate the larger role and potential of design in contemporary India.

## PROGRAMMES

The School is visualised as both a practice and research based school for the pursuit of design education from the undergraduate to the postgraduate and doctoral levels. It will begin by offering Masters programmes in Social Design, Service Design, Design History, Theory and Criticism.

# MA IN SOCIAL DESIGN

Design education has so far tended to emphasise the creation or transformation of particular objects with a focus on functional, artisanal or aesthetic ends.

Social design builds on this approach by bringing human needs to centre-stage. A social design education is thus actively people-centred, humanistic and empathetic with co-creation and participatory approaches as the leitmotifs of the design process it espouses.

The Programme in Social Design is a 2½-year, full time practice-based programme with a predominant social focus. It amalgamates methods, tools and approaches of design disciplines with those of the social sciences to creatively address complex issues of inclusion, access, equity and opportunities through participatory and co-creation processes. The emphasis of the Programme is on preparing students with the entrepreneurial competencies and leadership essential to addressing socially complex issues embedded within communities, agencies, organisations and states.

# **PROGRAMME** STRUCTURE

The Programme comprises **100** credits over five semesters of 16 weeks each of academic work including taught courses, studio projects, community presentations, research and self study culminating in a dissertation and thesis project on a real life brief. Internships and field studies form an integral part of learning through engagement with communities, organisations and NGOs in both rural and urban settings.

# **CAREER OPTIONS**

Graduates can find challenging and gratifying engagement with development agencies, NGOs, CSR initiatives of corporate organisations, government agencies, SHGs, community networks, social networks, academic and research organisations.



# FEATURES OF THE SCHOOL

To complement and strengthen its educational programmes, the SDes has initiated the following multidisciplinary Centres:

#### Futures Lab

Futures Lab will undertake real life and self-initiated projects to demonstrate the application of design in complex public - systems. Projects at the Lab would explore these systems to visualise emerging and preferred scenarios reflecting values of equity, access, participation, inclusion and opportunity.

#### Centre for Skills, Crafts and Vernacular Material Expression

Human systems and services are served by varied skills that emanate from the margins of the unorganised or underprivileged sector. They shape our selves, material culture, habitats and ecology; yet, they are not at the centre of our economic universe but at the periphery. The Centre for Skills, Crafts and Vernacular Material Expression seeks to study and understand this reality of contemporary India.

#### **Design Museum**

The School also plans to set up a Museum of Design in the near future. This will be the first of its kind in India and will become a major centre for research, study and reference for the understanding and articulation of design from a historical perspective to shape its emerging future in both local and global contexts.

#### School of Business Public Policy and Social Entrepreneurship (SBPPSE)

SBPPSE has been set up to promote research, provide professional education, and training in the fields of Business Administration, Public Policy and Social Entrepreneurship. In addition to the 2-year (full-time) MA Social Entrepreneurship programme, the School offers 2-year (full-time) MBA and 1-year PG Diploma Publishing programmes.

### MA in Social Entrepreneurship (MASE)

The MASE programme aims to introduce students to the emerging area of Social Entrepreneurship and the impact it can make on the economy and society.

The programme will familiarise students with the core business skills – finance, marketing, operations, human resource management and strategic management, which are essential for any organisation in the public, private or development sector.

The programme aims to foster an understanding of contemporary issues faced by businesses along with the operations of small and medium enterprises, which are the backbone of the Indian economy.

The highlights of MASE are that it imparts specialised skills required to start personal ventures and find creative as also innovative solutions to social problems. Students are expected to create their own social value propositions to bring about changes in the lives of communities.

The foundations of business management education are essential for building and pursuing social entrepreneurship. The core principles of business administration will be offered to the students of MASE along with the specialised courses on entrepreneurship, innovation and social consciousness.

The first year of the programme will comprise 3 trimesters of 12 weeks each and the second year will consist of 2 semesters of 16 weeks each. Field-based learning will be interspered over the two years. The first year of the programme will follow the same course structure as the MBA programme with minor modifications. In the second year, students will be exposed to a variety of core courses in the areas of development/social entrepreneurship. Students will also be given a choice of electives from the MBA programme as well as from those offered by other Schools of AUD. As part of the curriculum of MASE, students will be required to undertake:

(i) A field project of 2 months duration with an organisation, which includes preparation of the project appraisal, implementation plan, budgeting, cost benefit analysis and revenue modelling

(ii) A business plan for their own entrepreneurial ventures, which can be supported (with resources/ finances, etc) by the Incubation Centre of AUD or by a pool of venture capitalists.

#### Career Options

After successful completion of the MASE programme, graduates will be expected to start their own ventures in the social sector.

# SCHOOL OF LIBERAL STUDIES (SLS)

SLS offers a range of interdisciplinary and overlapping programmes that support, encourage and redefine liberal arts education through cutting-edge interdisciplinary courses, interactive pedagogy and learning that goes beyond classroom spaces.

# **MA SOCIOLOGY**

The MA Programme in Sociology is designed to equip students with the knowledge and skills that will make them engaged citizens of the world capable of critical thinking and reflective action. It focuses on orienting students to the relationship between text and context, self and society, and the past and present. It is hoped that students develop a reflexive awareness of the historicity of the social and the ability to locate the history of the discipline within the sociology of knowledge production. The Programme envisages its students as compassionate, engaged researchers and active learners committed to the principles of social justice. Graduates from our Programme are thus taught to think across disciplines and to ask questions from multiple vantage points while maintaining a firm sociological 'grounding' when exploring specific research issues.

## **DESCRIPTION OF CORE COURSES**

#### Social Theory 1: Classical Theory

This course explores frameworks of analysis, perspectives and paradigms that seek to explain society and aspects within it. It starts by exploring some foundational ideas and philosophies underlying social theories and then goes on to discuss the founders of theoretical discourses in sociology. The founding sociologists concentrated on are Karl Marx, Emile Durkheim, Max Weber and Georg Simmel.

#### Social Theory 2: Contemporary Theory

Our reading of contemporary theory is comparative and historical in ways that productively extend students' knowledge of classical social theory. This course examines exemplary works that address a range of social issues and develop varied theoretical standpoints — from later strands in hermeneutics to contemporary forms of discourse analysis, post-Marxism, post-structuralism, post-modernism, post-colonialism and feminism — which are germane to a wide variety of substantive fields in the social sciences.

#### Social Research

This course begins by introducing the epistemological foundations of a major methodological tradition in social sciences – Positivism and

its implications for the pursuit of research. Building on the debates on Positivism, the course trains students in the formulation of research problems, research design and various techniques of data collection. Here the objective of the course is to expose students to various statistical methods of data analysis and computer aided packages such as MS Excel, SPSS and AtLasti.

#### Sociology of Indian Society

This course introduces students to the growth and development of sociology in India and the debates pertaining to it. It traces the trajectories of 'can there be a Sociology of India' debate initiated in 1957 by Dumont and Pocock. Whether the tradition - modernity continuum is still a relevant frame, whether there are distinct schools as articulated by some scholars or whether historicising Indian society is a way out - are some of the questions the course will address. In addition, the course examines the dominant and central themes, namely village dynamics, caste and Kinship networks, of the early sociology in India and how the disciplinary focus gradually came to include themes on gender, sexuality, dalit studies, and media.

#### Culture, Hierarchy and Difference

This course examines the ways in which culture re/produces difference, hierarchy and inequality and produces individuals as cultural subjects. Reimagining a conventional course on Social Stratification, this course aims at theoretically understanding culture as a site where hierarchy and difference are played out. Besides, theoretically traversing subaltern and cultural studies pathways, issues in Indian culture and polity are some of the key debates.

#### Protests, Movements and Transformations

Social Movements and Protests as social phenomena are increasingly becoming ubiquitous in today's world. Instead of perceiving social movements as 'crowd pathology or 'mass hysteria', Sociology asserts that social movements are diverse, creative and progressive as they carry alternative voices and ultimately reconstruct society. While protests are the strategic manifestations of any social movement, social and political transformation is what they seek to achieve. The aim of this course is to make the students understand how social agents collectively strive for social change by questioning the established power structures of any society.

#### Economy, Polity and Society

This course aims to capture Indian society in transition, and studies the specific character of economic and political modernisations in India. It moves away from the trinity model whereby market, state and society appear as three distinct entities, towards an examination of the complex process of institution building shaped by colonial modernity and nation building in post-colonial India. The course exposes students to the changing political economy of India. Apart from looking at state and market as grand institutions articulating and drafting rules of governance, the course visits the idea of everyday state and market. The objective here is to view institutionalisation from the bottom.

#### Faith, Religion and Society

Religion, as a social phenomenon, is of critical importance in the contemporary world. The impact of positivism and classical modernity's fetish for science, however, brought about a momentary eclipse of the ideas of faith and divinity.and god appeared to be on the death bed in the social science discourse. The questions of and about life and death, the worldly and otherworldly continued to engage human minds. The course is important as it introduces students to the world of divinity and the structures of domination within it; and prepares them to make sense of the dynamics of diversity that exists and defines the world of faith and spirituality.

#### **Relationships and Affinities**

Study of society is a study of human relationships —through blood, marriage, adoption, friendship, and labour. The need for this course emanates from the complex and continuously changing nature of inter-personal relationships in modern, globalised societies. The theoretical perspective of the course is influenced by micro-sociology as the analytical point of departure is relationships and intimacies rather than heterosexual marriage and family.

Sociology Elective Courses\* Social Exclusion Agrarian Societies Law and Society Culture, Health and Systems of Healing Science, Technology and Society

\*Sociology Elective Courses are offered according to interests (and availability) of faculty members as well as expressed preferences of students. Course details will be provided before the commencement of each semester.

The Programme encourages students to take at least 8 credits of Elective Courses outside the discipline of Sociology to experiencing other knowledge areas. Non-Sociology courses taken by Sociology students have included Space and Spectatorship, Gender and Education, and Gendered Memory: Women Writings from the North East.

# SCHOOL OF CULTURE AND CREATIVE EXPRESSIONS (SCCE)

SCCE is visualised as a location that implements a new vision of art pedagogy and practice in the country. The School will provide a nurturing ground for the development of new and different art making practices and theoretical insights across the areas of Visual Art, Literary Art, Performance Art and Cinematic Art.

# **MA VISUAL ART**

The Visual Art Programme takes into view a crisis in the discipline of Fine Arts and therefore stresses the need for initiating a new model of pedagogy.

The systemic crisis in the available practices of high/ fine art allows a wide gap to exist between fine arts production, its circulation and the public sphere. The presence of art as a possessable fetishistic commodity has led to its insufficient visibility in the public gaze, and the unavailability of it for larger public purposes such as social instruction and empowerment.

Increasingly, there are examples of Indian artists' search for alternative practices, where individual and institutional interventions have led to the creation of unconventional possibilities of producing and circulating art. However, art teaching institutions have mostly shown apathy to such developments. Such apathy is also apparent towards non-objectifiable art, such as new media art, installation art, video art, new uses of photography, performance art, internet art, digital art etc. The very nature of these new mediums dematerialises art as concepts that simply cannot be owned. Significantly, such practices have also enabled artists to shift towards community oriented collaborations that challenge the conventional values enshrined in art.

The above inchoate developments would be gathered together to form a new pedagogical philosophy and structure in art education. The Programme undertakes to integrate various inputs of interdisciplinary nature combined with skills, methodological framework, conceptual thinking, theoretical and historical knowledge, socio-politico awareness and ethical integrity.

# THE NATURE AND CONTENT OF THE COURSES

The Foundation Courses, common to all students in the School, provide them with exposure to key texts in Critical Theory and Cultural Studies. The Elective Courses offered in the School explore interdisciplinary grounds of all the four programmes.

The Core Courses will explore both art making as well as critical reflection on the process of art making. Students will be introduced to the importance of concept development in art practice and provided a practical understanding regarding the relationship between concept and media. They will also be introduced to archive based research as a method of artistic practice. They will gain in-depth understanding of the foundational logics of digital media which would enable them to undertake cutting-edge experimental practices in this field. The basics of curatorial practices will be introduced both in terms of theory and practical considerations. This would enable the students not only to organise works of art in a conceptual framework, but also to think through processes of selection, modes of display, spatial and temporal dynamics, etc. in terms of the ways in which meanings are generated. The practical components of the courses will be realised through workshops and studio based practice.

# **PROGRAMME REQUIREMENTS**

Each course has its specific set of requirements which are spelt out during the orientation programme. The requirements may consist of regular attendance, classroom participation, critical engagement with the viewing of art exhibitions and events in the city and assignments. Students are expected to display their work at the end of workshops and semesters and to be able to write and speak critically about their own work.

The completion of the programme will depend on the completion of the required number of courses, voluntary participation in all activities of the School, a final curated display of a body of work, a dissertation and viva-voce.

# DURATION AND COURSE STRUCTURE

It is a two years course with two semesters each year. A semester is of 16 weeks duration. The students should register for a minimum 16 credits each semester and need to earn 64 credits to complete the Programme. They may register for more credits on payment of extra fees.

All the students of SCCE need to take three common foundational courses, one each in the first three semesters, for 12 credits in total. They should also take four Elective Courses offered by the School or any other School in the University, one each in all the four semesters, for 16 credits in total. They need to take seven compulsory Core Courses from their respective discipline for 28 credits in total. Their MA dissertation work and display in the final semester will earn them 8 credits.

## PG Diploma in Publishing (One-year full-time)

# **MA in Visual Art**

The Visual Art programme takes into view a crisis in the discipline of Fine Arts and therefore stresses the need for initiating a new model of pedagogy. The programme undertakes to integrate various inputs of interdisciplinary nature combined with \ skills, methodological framework, \conceptual thinking, theoretical and historical knowledge, socio-politico awareness and ethical integrity.

# MA in Literary Art (Creative Writing)

The programme has pioneered the pedagogy of creative writing in India with its unique insistence on inculcating in the student both the practice and the theory of literary writing. Rather than simply equip students already fluent in English with a set of supplementary skills, it teaches them to acquaint themselves with the literary idioms of the many languages of the sub-continent and of Europe. The programme is keen on fostering generic innovation as students write in a way that traverses genres, media (dance, film, theatre, the visual arts) and historical and geographic boundaries.

## MA in Performance Studies

MA in Performance Studies focuses on the pervasiveness of performance as a central element of social and cultural life, including not only theatre and dance but also such forms as rituals and practices of everyday life, avant-garde performance art, popular entertainment, sports, political demonstrations and potentially any instance of expressive behaviour or cultural enactment. The programme aims to contribute to the development of engaged scholarship in the field with a unique perspective given the rich and varied experience situated in and informed by the culture and heritage of India.

# **MA in Film Studies**

The programme tries to address the task of studying cinema in India in all its varieties in a global comparativist mode without subscribing to any pre-set hierarchy of aesthetic merit and artistic excellence. It seeks to bridge the gap between a philosophical understanding of film as an art form and the cultural studies understanding of its role as mass media drawing on the rich theoretical legacies of Benjamin, Kracauer and Deleuze among others. Particular attention is paid to the multi-sited film production in India not allowing the undue attention paid to Bollywood to eclipse the pluralisation of film cultures in India. The programme is equally interested in fostering historical. anthropological and textual analysis of cinema paving close attention to its embedded nature in the social and political history of the country.

## **PhD Programes**

The School offers PhD programmes in Visual Art, Literary Art and Film Studies. The unique feature of these programmes is that they have developed a curriculum structure for practice-based artistic research.

The MPhil Programme in Development Practice is offered jointly by the School of Human Studies (SHS) and the School of Development Studies (SDS) in collaboration with **PRADAN**.

# SCHOOL OF HUMAN STUDIES (SHS)

SHS is an explorative, interdisciplinary space for thinking and reflecting on the myriad meanings of being human. Academic programmes housed in the School focus on the promise and potential of the human along with the actual historical exclusions and marginalisations that humans have led to.

SHS has brought together psychologists, social anthropologists, sociologists, philosophers and social work professionals to offer interdisciplinary programmes.

# MPHIL IN WOMEN'S AND GENDER STUDIES

The AUD – Centre for Women's Development Studies (CWDS) collaboration provides the MPhil Programme with a diversified area of research. As a premier research centre, CWDS will provide students an unparalleled resource of active research projects to affiliate with, and a vibrant community of researchers who can supervise their dissertation/ thesis. This unique collaboration supplements the development approach to gender with the interdisciplinary resources at AUD, in particular literature, film, psychology, sociology, history and expressive cultures.

# **TEACHING METHODOLOGY**

The pedagogies of teaching and learning employed at Women's and Gender Studies are intended to inculcate a feminist sensibility in our students in ways that balance academic rigour with intellectual freedom.

Students are encouraged to experience the personal as political by bringing into the classroom spaces critical reflection on their own and others' life histories and activism in conjunction with feminist texts and theorisation.

# SYSTEM OF CREDITS

**MPHIL:** This is a 30 credit course, with one year of course work of 18 credits.

**DIRECT PHD:** Selected MPhil students, subject to performance, may proceed to doctoral research after completing 18 credits of courses of the MPhil Programme (without completing an MPhil thesis). Direct admission of doctoral scholars is also possible under the combined MPhil/PhD Programme.

Direct PhD in Women's and Gender Studies entails mandatory course work as allocated to the student. It will include specific courses designed to strengthen the core areas of research of each student and courses on methodology, theory or movements as required. The total number of credits of course work will depend on how many courses are allocated to each student and will vary accordingly.

# DISSERTATION

The MPhil dissertation in the second year of the Programme allows students to do independent research under supervision.

This is an opportunity to not only contribute to knowledge production in the field of Women's and Gender Studies but also to interpret and challenge existing knowledge systems with a gender-sensitive lens.

The research thus conducted is also expected to help students in identifying the potential areas of research and work to be taken up after the completion of their Programme. MEDIUM OF INSTRUCTION English

STIPEND All MPhil and PhD students are entitled to a stipend.



#### ELIGIBILITY

Candidates must have either already obtained an MPhil or those holding MSc/MA must have displayed special aptitude such as completion of a research thesis (or project of comparable scope) or scholarly publication(s) from a recognised University. They must have passed with at least 55% or an equivalent grade/ class.

Relaxation in marks for reserved categories as per the Government of NCT of Delhi norms.

Meeting the eligibility criteria will not ensure admission which will also be dependent on a research proposal, entrance test and interview.

**Research Proposal:** It should be up to five doublespaced pages and must be submitted with the application. The document should give a background of the proposed research, its questions/ objectives, a description of the chosen conceptual frameworks, and the historical-geographical context of the research.

The proposal should be sent to *researchshe@gmail. com*.The weightage of the Research Proposal to admission is 25%.

**Entrance Test:** It will comprise essay style questions addressing contemporary issues at the interface of environment and human society. It will presume an ability to respond to the questions from a broad social sciences perspective. Expected readings will be circulated beforehand.

#### The weightage of the Entrance Test is 50%.

#### The weightage of the Interview is 25%

Satisfactory performance in the admission procedure requires obtaining a minimum of 55% in proposal assessment, entrance test and interview combined for General and 50% for Reserved Category students.

#### SCHOOL OF HUMAN ECOLOGY (SHE)

SHE aims to develop a deep and multifaceted understanding of environmental issues that includes perspectives from the social and the natural sciences. The School expects its students to graduate with the knowledge and skills necessary to analyse and address environmental concerns keeping in mind social equity, academic rigour and ecological sustainability.

#### SUPERVISORY ARRANGEMENT

A Supervisor from SHE shall be assigned after the offer of an admission has been made. A PhD Advisory Committee (PAC) shall be constituted for each scholar, which would meet regularly to recommend coursework and monitor the research scholar's progress during the programme.

Candidates are encouraged to discuss their proposed research with possible supervisors at AUD before beginning the application process. Co-supervisory arrangements are possible with experts and scholars outside the School or even outside AUD on condition that they have recognised academic credentials, and the Research Studies Committee (RSC) of the School should be convinced that the involvement of this person would significantly enhance the quality of the doctoral scholar's research.

#### **COURSE WORK**

Candidates admitted without MPhil are required to complete a minimum of 16 credits of course work within a period of one or two semesters as prescribed by the RSC of the School.

The order in which these courses are completed and the number of credits to be undertaken in one or two semesters is determined by the RSC on the basis of the recommendation of the candidate's PhD Advisory Committee (PAC). The RSC has the right to prescribe course work even to admitted doctoral scholars already holding MPhil degrees.

Participation in course work presumes a scholar's residence in the Delhi region during the officially recognised academic year/ sessions and the scholar's regular attendance of classes and related exercises. Exceptions to the 'residency requirement' could be made for scholars who are prescribed course work or 'pre-thesis' learning activities of a kind which cannot be fulfilled at AUD or which the research studies committee specifically prescribes to be done in some other place/under special conditions.

Other courses and pre-submission activities could be prescribed to a doctoral scholar by the RSC, according to the scholar's particular research requirements.

#### FEES:

Rs.1,250 per credit for Course Work + Rs.5,000 per semester during Research/ Dissertation + Rs.500 per semester for Student Welfare Fund + Rs.5,000 as refundable Security Deposit. Partial support available for eligible candidates from the Student Welfare Fund; TA-ships may be offered to eligible candidates.

#### STIPEND:

As may be determined by the AUD Standing Committee Research from time to time.

#### MONITORING PROGRESS OF PhD CANDIDATES

The duration of the doctoral scholar's enrolment is subject to the general research studies regulations of AUD. Scholars enrolling with MPhil may submit a dissertation for examination no sooner than 18 months following enrolment, while those enrolling without MPhil may submit it no sooner than 24 months after enrolment.

Four milestones in the PhD process will be monitored by the supervisor and the RSC:

- Successful completion of coursework: normally within 12 months of enrolment.
- Presentation and defence of research synopsis: between 12 and 18 months after enrolment.
- Mid-term research seminar: public seminar to be arranged by the SHE RSC.
- PhD defence in presence of AUD supervisor, co-supervisor (if any), thesis examiners, and any other invited expert.

# FEATURES OF THE PROGRAMME

The PhD Programmes in Visual Art, Literary Art and Film Studies fork into two kinds of research possibilities. One is a regular PhD, a conspectus of critical enquiry and research related to the artistic stream or an innovative practice-based PhD that would reflect SCCE's pioneering notion of practice-based learning.

The practice-based dissertation is effectively a memoire, a sustained reflection on the origin and emergence of an artistic product (visual art repertoire, literary texts in different genres, for instance). It will have three components — a creative manifestation (a creative endeavour in whatever stage of completion that demonstrates sustained mediation on the research question), a reflexive written document (which is akin to a conventional thesis setting up the driving question, reflections on the creative processes and results achieved) and an archive (a memoire of the processes that lead to the creative work).

#### SEATS

PhD in Visual Art: 3 PhD in Literary Art: 2 PhD in Film Studies: 2 (including reservations in accordance with the Government of NCT of Delhi norms).

#### **ELIGIBILITY** (Essential)

The minimum eligibility is a postgraduate degree with a minimum 55% (B in the AUD grading scale) or its equivalent with a good academic standing from a recognised Institution. Exemptions may be made in the case of practitioners of exceptional merit with a convincing portfolio. Relaxation of 5% for candidates belonging to SC/ST/PD categories.



# SCHOOL OF CULTURE AND CREATIVE EXPRESSIONS (SCCE)

SCCE is visualised as a location that implements a new vision of art pedagogy and practice in the country.

The School will provide a nurturing ground for the development of new and different art-making practices and theoretical insights across the areas of Visual Art, Literary Art, Performance Art and Cinematic Art.

# **PHD AT SCCE**

The imperative of practice aligns SCCE postgraduate work to AUD's own cherished need to connect to concrete forms of life and livelihood. What is human about practice, which is also its humanitas, or in a Greek sense its paideia, is that it ennobles the pattern of a life in ways that have much in common with struggles around sexuality and gender.

This may seem counter-intuitive but the increased need to rally our desires and energies around forms of self-conduct that we choose for ourselves and that we cultivate for ourselves is evident in many spheres of Indian social life today.

Hence, too, the importance of the SCCE practice-based degree to the very future of the humanities, in as much as what is at stake is the possibility of an 'aesthetics of existence' that brings together theoretical-conceptual labour on the one hand, and artistic or technico-practical endeavour, on the other.

# **COURSE WORK**

The SCCE's MA is to be the benchmark for assessing the critical ability of the student. Hence, SCCE-MA students who proceed to register for PhD will have to complete 16 credits of PhD coursework over one year; whereas others will have to complete 32 credits in the same period.

Continuing Students of SCCE will enrol for two mandatory PhD level taught courses and two guided (independent) study courses.

The guided independent study, to be designed in consultation with a faculty member, has to be approved by the SCCE-Research Standing Committee (RSC) keeping in mind the intellectual inclinations of the candidate. Likewise the complementary MA courses for non-AUD students will be offered on the advice of SCCE-RSC in tune with the scholarly, interdisciplinary and philosophical training required by the proposed research.

# DURATION OF THE PROGRAMME

The minimum duration of the PhD programme is 3 years, which is extendable by another year on compelling reasons pertaining to the particular project.

The first two semesters, that is, the first year will consist of course work. The third semester will be devoted to the gestation of a fully-fledged research proposal accompanied by bibliographical/ referential evidence.

At a date, no later than the end of the third semester, the candidature of the student to a PhD degree would have been confirmed. The next three semesters and any period of extension will be spent in research, practice-based or otherwise.
