### 10.3.4 Proposal for a four credit PhD core course “Advance Econometrics for Livelihoods Research” in School of Human Ecology (SHE)

**Resolved** to accept the recommendation of SCR for a four credit PhD core course “Advance Econometrics for Livelihoods Research” in the School of Human Ecology vide **Appendix-6**. The following amendments in the course template were suggested: i) revising the course template to ensure that only the names of the current AUD faculty members are included; ii) under the heading “Overall Structure” item 10 in the template, instead of naming specific data-sets a general formulation, such as “large scale data-sets” be used.

In view of (i) above, the AC also recommended reviewing the SCAP’s proforma/format for courses with specific reference to the section mentioning the course coordinator and team names. It was recommended that it will be better to incorporate an alternative formulation for “course coordinator and team” (such as “piloted by”) that does not require bringing the revised course formats to the AC for approval in case the faculty members teaching the courses change over-time.

#### **10.4 Recommendations of the Standing Committee Student Affairs (SCSA)**

##### **10.4.1 Extension of span period beyond 5 years for two students of BA Honours Programmes**

**Resolved** to accept the recommendations of SCSA on extension of span period beyond 5 years to Ms Tanya Pruthi to complete her one compulsory course of BA Psychology and to Ms Chahat Lohiya to complete her BA Honours in English on medical grounds.

While acknowledging the need for a case-by-case review of such requests for extension, the Council recommended and authorised the SCSA to develop guidelines for the grant of extension. This was recommended in view of maintaining clarity in communication to students in the cases where the request of extensions may not get approved.

#### **10.5 Recommendations of the Standing Committee on Academic Programmes (SCAP)**

The Council took note of the minutes of the meetings of the Standing Committee on Academic Programmes (SCAP) held on 11.04.2017 & 25.04.2017 (vide **Appendix-8**) and **resolved** to approve the following recommendations of the SCAP:

##### **10.5.1 Discontinuation of the PG Diploma in Early Childhood Care and Education programme of the School of Education Studies**

**Resolved** to accept the recommendation of SCAP on discontinuation of the PG Diploma in Early Childhood Care and Education programme under School of Education Studies from the Academic year 2017-18.

##### **10.5.2(a) Increase in student intake from 32 to 42 for the existing MA Education and MA Education (Early Childhood Care & Education) programmes under the School of Education Studies (SES)**





**Resolved** to accept the recommendations of the SCAP to increase the student intake from 32 to 42 for the existing MA Education and MA Education (Early Childhood Care & Education) programmes of the SES.

**(b) Revised courses of the 2nd year MBA programme for the School of Business Public Policy and Social Entrepreneurship (SBPPSE) as recommended by the SCAP.**

**Resolved** to accept the revised courses of the 2nd year MBA programme for the School of Business Public Policy and Social Entrepreneurship (SBPPSE) to be introduced from the academic year 2017-18, as recommended by the SCAP, vide **Appendix-9**.

#### **10.5.3 Revised programme structure for the four MA programmes being offered by the School of Culture & Creative Expressions (SCCE)**

**Resolved** to accept the recommendations of the SCAP on the revised programme structure for the four MA programmes of the SCCE, vide **Appendix-10**.

#### **10.5.4 Introduction of new courses and changes in the existing programme structure of MA in Environment and Development, School of Human Ecology (SHE)**

**Resolved** to approve the recommendations of the SCAP on the introduction of the following three new courses in the MA in Environment and Development, School of Human Ecology (SHE): (i) Contested Atmospheres: The Political Ecology of Urban Air (2 credits) (ii) Conservation and Livelihoods (2 credits) and (iii) Ecology and Society (4 credits) (this course is available only to students enrolled in other MA programmes except MA in Environment & Development Students), vide **Appendix-11**.

In the context of (iii) above it was suggested that in future while designing courses that are offered exclusively to programmes outside a School, allocation of teaching time be carefully considered.

Also, **resolved** to approve the following changes in the MA in Environment and Development programme structure: (i) shift of the core course "Environmental and Ecological Economics" to Semester 2 of the programme;



(ii) the revision of the name of the course "Ecological Statistics 2" to "Ecological Statistics".

#### **10.6. Other Items:**

##### **10.6.1 Draft Scheme of Seed Money Grant for Faculty Research (SMGFR) as recommended by the Advisory Committee on Research and Project Management (ACRPM)**

**Resolved** to approve the draft scheme of one-time Seed Money Grant for Faculty Research (SMGFR) for up to an amount of Rs.1,00,000/- as recommended by the ACRPM in its meeting held on 06.04.2017 with the following changes/modifications:

- (i) Incorporation of a brief outline of the peer review of the output of the faculty research and the necessity of submission of a written report on completion of the grant for the purposes of recording.
- (ii) While the SMGFR is a one-time grant, the output of the research that is found to be of good quality may be encouraged by some other provisions like consideration for further award of grant under some other appropriate scheme.
- (iii) Revision in the details mentioned under the provision pertaining to the use of the Seed Money Grant (item h of the draft Scheme document). The provision should be stated generically. The details of how the grant is proposed to be used should be included in the proposals submitted by faculty members applying for the grant.

The revised scheme with the recommendations suggested by the Academic council is in **Appendix-12**.

##### **10.6.2 Adoption of Policy regarding Teacher-Student Ratio for UG/PG courses of AUD as per the UGC/MHRD guidelines**

The Council considered the proposal regarding the 'Adoption of a policy regarding Teacher-Student Ratio for various UG/PG programmes in AUD'. AUD's aim is to provide equitable access along with the pursuit of excellence. The quest for excellence in its initial phase has manifested itself in the nature





of programmes that were established, in faculty recruitment, the very favourable teacher-student ratio, and the attempt to institutionalise progressive curricular and assessment structures and processes. As a university focused on teaching and research in social sciences and humanities, with an emphasis on inter-disciplinarity and praxis-based teaching-learning, AUD has to maintain a small cohort size to facilitate adoption of innovative pedagogies. To sustain the pedagogies adopted by the various programmes in the University, a healthy teacher-student ratio has to be maintained. With the phenomenal growth of the University and its spreading out in multiple campuses, it is imperative to maintain the same standards that have helped AUD in achieving its current recognition in the short period of its existence.

The Council also noted that while the University Grants Commission (UGC) has prescribed norms for Teacher-Student ratio for UG and PG level from time to time, these norms should be looked at as the minimum standards to be maintained by all higher education institutions. These norms should not be used as a benchmark for universities, especially for those that aim to provide quality education comparable to the best in the world. It further noted that high quality research should remain an important objective of the University if it has to remain relevant in a highly competitive world of higher education. It also noted that the current thinking and policies on higher education at the national level are cognizant of the need to take Indian universities closer to global standards, and one of the most important factors in this is to maintain a healthy student-teacher ratio.

After detailed deliberations, the Council **resolved** to maintain a uniform teacher-student ratio of 1:15 at the University level which is in consonance with the accepted contemporary wisdom in Indian Higher Education, and the requirements of the University.

The Vice Chancellor apprised the members that at present the Standing Committee on Academic Programmes (SCAP) considers the matters related to all programmes other than MPhil and PhD programmes of the University. Even the professional programmes like MBA and those in Publishing and Social Entrepreneurship have so far been processed by SCAP. However, there are a number of new professional, vocational and continuing education programmes that the University is likely to launch in the near future. For instance, the newly created School of Vocational Studies (SVS) would be offering a Bachelor of Vocation (BVoc) programme with effect from the academic session 2017-18. The professional, vocational and continuing education programmes are distinct in nature from the academic programmes offered by the University through its various Schools. Therefore, there is a need for a separate Standing Committee to examine proposals from the various Schools for Professional, Vocational and Continuing Education Programmes, and



make appropriate recommendations from time to time for the consideration of the Academic Council.

After due deliberation, the Academic Council **resolved** to approve the constitution of a Standing Committee on Professional, Vocational and Continuing Education Programmes (SCPVCE) with the following composition:

- i) Dean, School of Design
- ii) Dean, School of Human Studies
- iii) Dean, School of Business, Public Policy & Social Entrepreneurship
- iv) Dean, School of Education Studies
- v) Dean, School of Vocational Studies
- vi) Dean, School of Law, Governance and Citizenship
- vii) Director, Centre for Social Science Research Methods
- viii) Director, Centre for Early Childhood Education and Development
- ix) Director, Centre for Psychotherapy and Clinical Research
- x) Director, Centre for Development Practice
- xi) Director, Centre for English Language Education
- xii) Director, Centre for Publishing
- xiii) Director, AUD Centre for Incubation, Innovation & Entrepreneurship

Professor Jatin Bhatt shall be the Chairperson of this Standing Committee till further orders.

The Standing Committee would deliberate on all matters related to professional, vocational and continuing education programmes and make recommendations from time to time for the consideration of the Academic Council.

#### **10.12.2 Exploring assessment reforms and reviewing assessment practices as a part of decennial review of AUD activities:**

On the suggestions by one of its members, the Council recommended that AUD may consider exploring and pioneering reform in assessment practices at higher education level so as to include generic skills, such as critical thinking, in the fold of assessment. This could be included as part of the decennial review undertaken by the University.

Shri B. Mallesha, Assistant Registrar (VCO & Governance) assisted the meeting.

At the outset, the Vice Chancellor (VC) extended a warm welcome to the Members of the AC and the Special Invitees. He welcomed Dr Sunita Singh, Dean (Offg.), School of Education Studies (SES) as a new member of the Council.

The following **resolutions** were passed:

**15.1 Confirmation of the minutes of the 14<sup>th</sup> meeting of the AC held on 05.12.2017**

The Council **resolved** to confirm the minutes of the 14<sup>th</sup> meeting of the AC held on 05.12.2017, as circulated on 09.02.2018.

**15.2 Action Taken Report (ATR) on the minutes of the 14<sup>th</sup> meeting of the Academic Council held on 05.12.2017**

The Council **resolved** to note the Action Taken Report (ATR) on the decisions taken in its 14<sup>th</sup> meeting held on 05.12.2017, vide **Appendix-1**.

**15.3 The recommendations of the Sub-Committee regarding the Students' Union Constitution (SUC)**

The AC in its 14<sup>th</sup> meeting held on 05 December 2017 vide its resolution no. 14.3.1, had resolved to constitute a Sub-Committee regarding the SUC with the following members: a. Professor Farida A. Khan (Government nominee on the AC) (Chair), b. Professor Sanjay Kumar Sharma (Dean, Student Services) (Convener), c. Professor Anup Kumar Dhar (Chair, ACRPM) (Member), d. Professor Lawrence Liang (Dean, SLGC) (Member); and e. Dr Rajan Krishnan (Officiating Dean, SCCE) (Member). The mandate of the Committee was to: a. draft a communication to the students informing them about the SUC and the process through which it was arrived at; b. draft a ready reckoner on the constitution for the students to be appended with the communication; c. evolve ways in which greater student participation could be elicited; and d. complete these processes by the end of January 2018. The Sub-Committee submitted its Report for the consideration of the AC, vide **Appendix-2**.

The AC noted that the draft SUC was also discussed in the 13<sup>th</sup> (vide resolution no. 13.3.1) and 14<sup>th</sup> (vide resolution no. 14.3.1) Meetings of the Council. The members of the AC appreciated the serious engagement and creative efforts of the students in drafting the SUC. The AC also took note of the observations of the Standing Committee of the Academic Council on Student Affairs (SCSA) and legal experts on the constitution submitted by students. The AC was of the opinion that future student representatives may benefit from these observations, hence they are advised and urged to take them into consideration.

After extensive deliberations on the matter, the AC **resolved** the following:

- i. The constitution of the Students' Union submitted by the elected Students' Council of 2016-17 be finalised incorporating the two directions stated below:
  - a. Article 11 (on 'Psychological Care') and Article 12 ('Research Institute for Reservations') be removed as these are outside the purview of the SUC and the ambit of the Student Council.
  - b. All provisions of the SUC in their current and future versions should comply with the prevailing general laws and the Constitution of the country, be in compliance with recommendations of the Lyngdoh Committee as per the order dated the 22<sup>nd</sup> of September, 2006 of the Supreme Court of India (vide **Appendix-3**) and in conformity with all relevant and appropriate regulatory/legal/policy frameworks related to student representation applicable from time to time.
- ii. All future amendments in the SUC proposed through due process be placed before the appropriate statutory bodies of the University for approval.

The AC **directed** the Student Services Division to finalise the SUC incorporating the aforesaid directions of the AC and the same be placed before the appropriate statutory bodies of the University for approval.

#### 15.4 The report of the Committee in the case of Shri Akunth, a student of BA (SSH), SUS, to identify the lapses on the part of the system

The AC in its 12<sup>th</sup> meeting held on 11.10.2017, vide its resolution no. 12.8.1 (concerning the case of Shri Akunth, second year student of BA (SSH), SUS), had "**resolved** to constitute a committee comprising the following members to identify the lapses on the part of the teachers and other constituents of the system and recommend appropriate actions to be initiated. Further, the committee shall come up with concrete suggestions in order to ensure an appropriate system in place to ensure non-recurrence of such lapses in future: a. Pro-Vice Chancellor-II (Chair); b. Dean, Assessment, Evaluation and Student Progression; c. Dean, Student Services; d. Dean, Academic Services; e. Dean, School of Human Studies; and f. Dean, School of Undergraduate Studies".

In pursuance of the above direction of the AC, the Committee had looked into the matter and submitted its first report to the Vice Chancellor on 10.11.2017. On receipt of this report, the Vice Chancellor made the following observations: "As Chairperson of the Academic Council, it is my sense that the report of the Committee does not measure up to the mandate given to it by the Academic Council. The Committee needs to go deeper into the systemic issues involved, look at the case in point in its full context and history, and come out with a more comprehensive report. The Committee is requested to submit its report by the 30<sup>th</sup> of November, 2017." In the context of these observations of the Vice Chancellor, the Committee had reworked on the matter and submitted its final report on 04.12.2017, vide **Appendix-4**.

The AC took note of the report and **resolved** to refer it to the Academic Services for further action after consultation with the current and former Deans of the concerned Schools.

### 15.5 The report of the Committee to Streamline the ERP System to avoid the problems related to grades, attendance records etc. of the students

In pursuance of the decision of the 12<sup>th</sup> AC Meeting held on 11.10.2017 as regards the case of Shri Akunth, second year student of BA SSH, the VC had constituted a Committee to streamline the ERP system in order to avoid the problems related to grades, attendance records etc., of the students. The Committee had the following composition (notified on 21.11.2017): a. Professor Chandan Mukherjee, Director IT Services (Chairperson); b. Professor Geetha Venkataraman, Dean AES; c. Dr. Taposik Banerjee, Assistant Professor SLS; d. Shri Harsh Kapoor, Assistant Registrar AES.

The AC **resolved** to accept the recommendations of the Committee and directed the AES Division and IT Services to take necessary actions as recommended by the Committee, vide **Appendix-5**.

### 15.6 The draft Concept Note on the Centre for Engaged Spiritualities and Peace Building (CESPB)

After deliberations on the Concept Note (**Appendix-6**) on the Centre for Engaged Spiritualities and Peace Building (CESPB), the AC directed the following:

- i. Since 'peace building' is subsumed in the conception of 'spirituality' (and also because the Centre proposes to mainly focus on spirituality) the name of the Centre should be changed to 'Centre for Engaged Spiritualities'.
- ii. While the Centre proposes to function with minimal organisational funding, the minimal budget heads required from the University should be built in the note. The organisational structure and the advisory committee for the Centre also need to be conceptualised in due course.
- iii. In addition to the activities proposed in the concept note, the AC suggested that as the Centre evolves, it could consider working in the following directions:
  - a. Identify and list the courses, already on offer across the Schools at AUD, that relate to the Centre's vision and organise them to offer certificate programmes;
  - b. Conceptualise short courses/engagements for the current students to enable them to work with conflict affected communities;
  - c. Contribute to the conceptualisation of capstone courses/programme at the undergraduate level; and
  - d. Contribute suitably to the continuing professional development of faculty and non-teaching staff.

The AC **resolved** to recommend the setting up of the Centre for Engaged Spiritualities (CES) for the consideration of the Board of Management.

### 15.7 The Concept Note on Philosophy at AUD

The AC **resolved** to in-principle approve the note (**Appendix-7**) on Philosophy at AUD with the following directions:





- i. The note should consider expanding its scope to include a wider range of philosophical perspectives/traditions (including Indian and indigenous systems of thought)
- ii. The note should be further elaborated to explain the nature of activities that will be pursued
- iii. Attempts should be made to integrate the already existing/interests in Philosophy across the Schools
- iv. The possibility of offering taught courses should not be ruled out and may be considered at a later stage.

### **15.8 The draft rules for student promotion and progression for on-the-job training component in the BVoc programmes**

The AC **resolved** to approve the progression rules for on-the-job training (OJT) component in the BVoc programmes of the School of Vocational Studies (SVS) with the **direction** that the complete Student Progression and Promotion Policy for the BVoc programmes be presented in the subsequent meetings of the AC after due approvals at various levels. It was recommended that the School should consider increasing the minimum passing grade in the OJT component from C Plus to B Minus – the AUD assessment policy provisions allow for this in the case of field and dissertation components. The revised note with progression rules for the OJT component of BVoc Programmes is at **Appendix-8**.

### **15.9 Recommendations of the Standing Committee on Academic Programmes (SCAP)**

The AC took note of the minutes (**Appendix-9**) of the meetings of the SCAP held on 29.12.2017 and 30.01.2018 **resolved** the following:

#### **15.9.1 The course outlines of 3 elective courses to be offered in the MA History programme and 3 elective courses to be offered in the MA Economics programme of the School of Liberal Studies (SLS):**

The following courses of the MA History and MA Economics programmes of SLS were presented (**Appendix-10**) in the AC meeting:

- i. MA History: 3 elective courses of 4 Credits each
  - a. Hunger, Disease and Welfare, India: 1750s-1950s (4 Credits, Elective)
  - b. Society and Culture in Early Modern Europe (4 Credits, Elective)
  - c. Partitions in South Asia (4 Credits, Elective)
- ii. MA Economics: 3 elective courses of 4 credits each
  - a. Networks: Theory and Applications (4 Credits, Elective)
  - b. Labour and Development (4 Credits, Elective)
  - c. Environmental Economics (4 Credits, Elective)

The AC **resolved** to approve the above courses with the following directions:

- i. The reading lists of the courses (especially Hunger, Disease and Welfare, India: 1750s-1950s) be organized in essential and supplementary readings

- ii. The updated MA Economics elective courses be presented in the most recent SCAP format for courses.
- iii. The overlap between the contents of the MA Economics electives (especially 'Labour and Development' and 'Environmental Economics') and courses on similar themes on offer in SDS and SHE be mapped. Based on this mapping, the possibility of co-teaching parts of the courses be explored. Such mapping of similar courses should be a general practice adopted at the School level before proposing a new course.

**15.9.2 The course outline of the elective, Multilingual Education in the Indian Context, to be offered in the MA Education and MA Education (ECCE) programmes of the School of Education Studies (SES):**

After due deliberations, the AC **resolved** to approve the course outline of the course Multilingual Education in the Indian Context (4 Credits, Elective) (**Appendix-11**) with the following directions:

- i. Since the course is on offer in the MA Education programmes, its focus should be on the practice-based aspects of multilingual teaching-learning contexts and thus a practicum component should be included in the course.
- ii. Since transition from home language to school language is a major concern in the Indian context, it should be one of the focal areas to be dealt with in the course.

**15.9.3 The reallocation of 1 credit from the field attachment component to the Introductory Statistics in Education workshop in the MA Education (ECCE) programme of SES**

The AC **resolved** to approve the reallocation of 1 credit from the field attachment component to the Introductory Statistics in Education workshop in the MA Education (ECCE) programme of SES. The workshop has already been approved in the MA Education programme in 2013 (**Appendix-12**).

**15.9.4 The course outlines of 4 elective courses to be offered in the various programmes of the School of Culture and Creative Expressions (SCCE):**

The AC **resolved** to approve the outlines of the following electives to be offered in the SCCE (**Appendix-13**) as per the following details:

- i. Crafting Poem (4 Credits, Elective), MA Literary Art programme
- ii. Media Objects/Media Theory (4 Credits, Elective), MA Film Studies programme
- iii. Musical Theatre (4 Credits, Elective), MA Performance Studies programme
- iv. Art and Public Response: Censorship, Dissent, Protest and Resistance in Contemporary Art (4 Credits, Elective), MA Visual Art programme

**15.9.5 The course outlines of 6 courses to be offered in the MA Law, Politics and Society programme of the School of Law, Governance and Citizenship (SLGC):**

- iv. Comparative Constitutional Law (4 Credits, Elective)
- v. Law and Modernity (4 Credits, Elective)
- vi. Law, Media & Technology (4 Credits, Elective)

**15.12 Take cognizance of the amendments in the various UGC Regulations regarding recruitment and career advancement of the faculty**

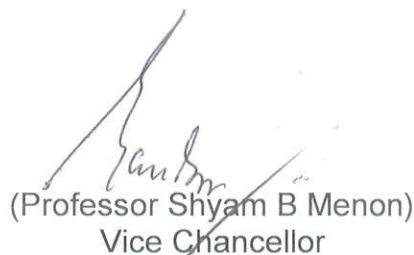

Shri B. Mallesha, Assistant Registrar (VCO & Governance) assisted the meeting.

At the outset, the Vice Chancellor (VC) extended a warm welcome to the Members of the AC and the Special Invitees. He welcomed Dr Sunita Singh, Dean (Offg.), School of Education Studies (SES) as a new member of the Council.

The following **resolutions** were passed:

**15.1 Confirmation of the minutes of the 14<sup>th</sup> meeting of the AC held on 05.12.2017**

The Council **resolved** to confirm the minutes of the 14<sup>th</sup> meeting of the AC held on 05.12.2017, as circulated on 09.02.2018.

**15.2 Action Taken Report (ATR) on the minutes of the 14<sup>th</sup> meeting of the Academic Council held on 05.12.2017**

The Council **resolved** to note the Action Taken Report (ATR) on the decisions taken in its 14<sup>th</sup> meeting held on 05.12.2017, vide **Appendix-1**.

**15.3 The recommendations of the Sub-Committee regarding the Students' Union Constitution (SUC)**

The AC in its 14<sup>th</sup> meeting held on 05 December 2017 vide its resolution no. 14.3.1, had resolved to constitute a Sub-Committee regarding the SUC with the following members: a. Professor Farida A. Khan (Government nominee on the AC) (Chair), b. Professor Sanjay Kumar Sharma (Dean, Student Services) (Convener), c. Professor Anup Kumar Dhar (Chair, ACRPM) (Member), d. Professor Lawrence Liang (Dean, SLGC) (Member); and e. Dr Rajan Krishnan (Officiating Dean, SCCE) (Member). The mandate of the Committee was to: a. draft a communication to the students informing them about the SUC and the process through which it was arrived at; b. draft a ready reckoner on the constitution for the students to be appended with the communication; c. evolve ways in which greater student participation could be elicited; and d. complete these processes by the end of January 2018. The Sub-Committee submitted its Report for the consideration of the AC, vide **Appendix-2**.

The AC noted that the draft SUC was also discussed in the 13<sup>th</sup> (vide resolution no. 13.3.1) and 14<sup>th</sup> (vide resolution no. 14.3.1) Meetings of the Council. The members of the AC appreciated the serious engagement and creative efforts of the students in drafting the SUC. The AC also took note of the observations of the Standing Committee of the Academic Council on Student Affairs (SCSA) and legal experts on the constitution submitted by students. The AC was of the opinion that future student representatives may benefit from these observations, hence they are advised and urged to take them into consideration.

After extensive deliberations on the matter, the AC **resolved** the following:

- i. The constitution of the Students' Union submitted by the elected Students' Council of 2016-17 be finalised incorporating the two directions stated below:
  - a. Article 11 (on 'Psychological Care') and Article 12 ('Research Institute for Reservations') be removed as these are outside the purview of the SUC and the ambit of the Student Council.
  - b. All provisions of the SUC in their current and future versions should comply with the prevailing general laws and the Constitution of the country, be in compliance with recommendations of the Lyngdoh Committee as per the order dated the 22<sup>nd</sup> of September, 2006 of the Supreme Court of India (vide **Appendix-3**) and in conformity with all relevant and appropriate regulatory/legal/policy frameworks related to student representation applicable from time to time.
- ii. All future amendments in the SUC proposed through due process be placed before the appropriate statutory bodies of the University for approval.

The AC **directed** the Student Services Division to finalise the SUC incorporating the aforesaid directions of the AC and the same be placed before the appropriate statutory bodies of the University for approval.

#### 15.4 The report of the Committee in the case of Shri Akunth, a student of BA (SSH), SUS, to identify the lapses on the part of the system

The AC in its 12<sup>th</sup> meeting held on 11.10.2017, vide its resolution no. 12.8.1 (concerning the case of Shri Akunth, second year student of BA (SSH), SUS), had "**resolved** to constitute a committee comprising the following members to identify the lapses on the part of the teachers and other constituents of the system and recommend appropriate actions to be initiated. Further, the committee shall come up with concrete suggestions in order to ensure an appropriate system in place to ensure non-recurrence of such lapses in future: a. Pro-Vice Chancellor-II (Chair); b. Dean, Assessment, Evaluation and Student Progression; c. Dean, Student Services; d. Dean, Academic Services; e. Dean, School of Human Studies; and f. Dean, School of Undergraduate Studies".

In pursuance of the above direction of the AC, the Committee had looked into the matter and submitted its first report to the Vice Chancellor on 10.11.2017. On receipt of this report, the Vice Chancellor made the following observations: "As Chairperson of the Academic Council, it is my sense that the report of the Committee does not measure up to the mandate given to it by the Academic Council. The Committee needs to go deeper into the systemic issues involved, look at the case in point in its full context and history, and come out with a more comprehensive report. The Committee is requested to submit its report by the 30<sup>th</sup> of November, 2017." In the context of these observations of the Vice Chancellor, the Committee had reworked on the matter and submitted its final report on 04.12.2017, vide **Appendix-4**.

The AC took note of the report and **resolved** to refer it to the Academic Services for further action after consultation with the current and former Deans of the concerned Schools.

### 15.5 The report of the Committee to Streamline the ERP System to avoid the problems related to grades, attendance records etc. of the students

In pursuance of the decision of the 12<sup>th</sup> AC Meeting held on 11.10.2017 as regards the case of Shri Akunth, second year student of BA SSH, the VC had constituted a Committee to streamline the ERP system in order to avoid the problems related to grades, attendance records etc., of the students. The Committee had the following composition (notified on 21.11.2017): a. Professor Chandan Mukherjee, Director IT Services (Chairperson); b. Professor Geetha Venkataraman, Dean AES; c. Dr. Taposik Banerjee, Assistant Professor SLS; d. Shri Harsh Kapoor, Assistant Registrar AES.

The AC **resolved** to accept the recommendations of the Committee and directed the AES Division and IT Services to take necessary actions as recommended by the Committee, vide **Appendix-5**.

### 15.6 The draft Concept Note on the Centre for Engaged Spiritualities and Peace Building (CESPB)

After deliberations on the Concept Note (**Appendix-6**) on the Centre for Engaged Spiritualities and Peace Building (CESPB), the AC directed the following:

- i. Since 'peace building' is subsumed in the conception of 'spirituality' (and also because the Centre proposes to mainly focus on spirituality) the name of the Centre should be changed to 'Centre for Engaged Spiritualities'.
- ii. While the Centre proposes to function with minimal organisational funding, the minimal budget heads required from the University should be built in the note. The organisational structure and the advisory committee for the Centre also need to be conceptualised in due course.
- iii. In addition to the activities proposed in the concept note, the AC suggested that as the Centre evolves, it could consider working in the following directions:
  - a. Identify and list the courses, already on offer across the Schools at AUD, that relate to the Centre's vision and organise them to offer certificate programmes;
  - b. Conceptualise short courses/engagements for the current students to enable them to work with conflict affected communities;
  - c. Contribute to the conceptualisation of capstone courses/programme at the undergraduate level; and
  - d. Contribute suitably to the continuing professional development of faculty and non-teaching staff.

The AC **resolved** to recommend the setting up of the Centre for Engaged Spiritualities (CES) for the consideration of the Board of Management.

### 15.7 The Concept Note on Philosophy at AUD

The AC **resolved** to in-principle approve the note (**Appendix-7**) on Philosophy at AUD with the following directions:





- i. The note should consider expanding its scope to include a wider range of philosophical perspectives/traditions (including Indian and indigenous systems of thought)
- ii. The note should be further elaborated to explain the nature of activities that will be pursued
- iii. Attempts should be made to integrate the already existing/interests in Philosophy across the Schools
- iv. The possibility of offering taught courses should not be ruled out and may be considered at a later stage.

### **15.8 The draft rules for student promotion and progression for on-the-job training component in the BVoc programmes**

The AC **resolved** to approve the progression rules for on-the-job training (OJT) component in the BVoc programmes of the School of Vocational Studies (SVS) with the **direction** that the complete Student Progression and Promotion Policy for the BVoc programmes be presented in the subsequent meetings of the AC after due approvals at various levels. It was recommended that the School should consider increasing the minimum passing grade in the OJT component from C Plus to B Minus – the AUD assessment policy provisions allow for this in the case of field and dissertation components. The revised note with progression rules for the OJT component of BVoc Programmes is at **Appendix-8**.

### **15.9 Recommendations of the Standing Committee on Academic Programmes (SCAP)**

The AC took note of the minutes (**Appendix-9**) of the meetings of the SCAP held on 29.12.2017 and 30.01.2018 **resolved** the following:

#### **15.9.1 The course outlines of 3 elective courses to be offered in the MA History programme and 3 elective courses to be offered in the MA Economics programme of the School of Liberal Studies (SLS):**

The following courses of the MA History and MA Economics programmes of SLS were presented (**Appendix-10**) in the AC meeting:

- i. MA History: 3 elective courses of 4 Credits each
  - a. Hunger, Disease and Welfare, India: 1750s-1950s (4 Credits, Elective)
  - b. Society and Culture in Early Modern Europe (4 Credits, Elective)
  - c. Partitions in South Asia (4 Credits, Elective)
- ii. MA Economics: 3 elective courses of 4 credits each
  - a. Networks: Theory and Applications (4 Credits, Elective)
  - b. Labour and Development (4 Credits, Elective)
  - c. Environmental Economics (4 Credits, Elective)

The AC **resolved** to approve the above courses with the following directions:

- i. The reading lists of the courses (especially Hunger, Disease and Welfare, India: 1750s-1950s) be organized in essential and supplementary readings

- ii. The updated MA Economics elective courses be presented in the most recent SCAP format for courses.
- iii. The overlap between the contents of the MA Economics electives (especially 'Labour and Development' and 'Environmental Economics') and courses on similar themes on offer in SDS and SHE be mapped. Based on this mapping, the possibility of co-teaching parts of the courses be explored. Such mapping of similar courses should be a general practice adopted at the School level before proposing a new course.

**15.9.2 The course outline of the elective, Multilingual Education in the Indian Context, to be offered in the MA Education and MA Education (ECCE) programmes of the School of Education Studies (SES):**

After due deliberations, the AC **resolved** to approve the course outline of the course Multilingual Education in the Indian Context (4 Credits, Elective) (**Appendix-11**) with the following directions:

- i. Since the course is on offer in the MA Education programmes, its focus should be on the practice-based aspects of multilingual teaching-learning contexts and thus a practicum component should be included in the course.
- ii. Since transition from home language to school language is a major concern in the Indian context, it should be one of the focal areas to be dealt with in the course.

**15.9.3 The reallocation of 1 credit from the field attachment component to the Introductory Statistics in Education workshop in the MA Education (ECCE) programme of SES**

The AC **resolved** to approve the reallocation of 1 credit from the field attachment component to the Introductory Statistics in Education workshop in the MA Education (ECCE) programme of SES. The workshop has already been approved in the MA Education programme in 2013 (**Appendix-12**).

**15.9.4 The course outlines of 4 elective courses to be offered in the various programmes of the School of Culture and Creative Expressions (SCCE):**

The AC **resolved** to approve the outlines of the following electives to be offered in the SCCE (**Appendix-13**) as per the following details:

- i. Crafting Poem (4 Credits, Elective), MA Literary Art programme
- ii. Media Objects/Media Theory (4 Credits, Elective), MA Film Studies programme
- iii. Musical Theatre (4 Credits, Elective), MA Performance Studies programme
- iv. Art and Public Response: Censorship, Dissent, Protest and Resistance in Contemporary Art (4 Credits, Elective), MA Visual Art programme

The Hon'ble Lt Governor of Delhi, Shri Anil Baijal, in his capacity as the Chancellor of the University presided over the Convocation ceremony.

568 students who completed the prescribed requirements during the academic year 2016-17 were awarded with PhD, MPhil, MBA, MA, BA (Hons) Degrees in various fields of studies. Post Graduate Diplomas in Development Studies, Early Childhood Care & Education and Environment & Development were also awarded.

The composition of the students who received their degrees and diplomas is as follows: BA (Hons): 161, MA: 342, MBA: 38, MPhil: 13, PhD: 7, PG Diploma: 7. Out of the total number of students who were awarded degrees and diplomas, 65% were women. The data of degrees awarded in the Sixth Annual Convocation is at **Appendix-15**.

**15.12 Take cognizance of the amendments in the various UGC Regulations regarding recruitment and career advancement of the faculty**

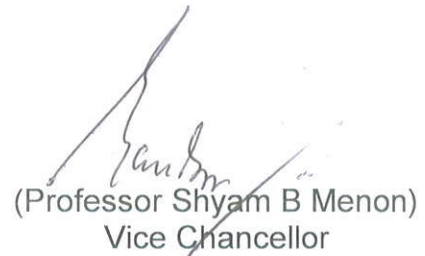

Agenda of the BOS:

- Minutes of SCCE's 9<sup>th</sup> Board of Studies meeting was passed
1. To perform a review of four (Performance Studies, Literary Art, Visual Art, Cinema Studies) of SCCE's five programs.
  2. Present two new courses from the Literary Art Creative Writing program for approval before the BOS

Minutes:

1. The BOS made several suggestions regarding the further development of the individual programs and the School itself in response to the presentations made by the programs. Details of these suggestions are outlined below.
2. The two courses in question: i. 'Seven Forms of Poetry' (Dr. Akhil Katyal) and, ii. 'Contexts and Conditions of Production: Considering Cultural Infrastructures' (Dr. Anita Cherian) were both approved by the BOS with certain small changes

suggested that were to be incorporated before they were presented before the SCAP;

**I. BOS comments on the Program review:**

1. Benil Biswas presented an overview of the Performance Studies program as it exists today and the principal concerns felt by faculty with regard to student performance and course transaction. In response to concerns expressed regarding students' ability to engage in sustained writing and reflection such as that required in the mandatory dissertation, BOS members suggested possibilities such as a reconsidering of the form of the dissertation, perhaps a performed/visual/ creative submission. Others members were of the opinion that students should not be absolved of the responsibilities of reading, writing and research (Ira Bhaskar, Deepan Sivaraman).
2. The urgent requirement for a critical writing program to inculcate practices of analytic writing and thinking was affirmed by members of the BOS. The suggestion was made that the summer break might be used to develop a writing practice. Ira Bhaskar pointed out that at universities such as JNU a critical writing course is now a compulsory component of the MA degree. Even students of the Practice programs need to invest in writing, in order, for instance, to be able to write proposals for funding.
3. The importance of a detailed program review, including an analysis of where graduates find themselves, after five years was emphasized by Suchitra Balasubramanyam ('five years is a generation'). She suggested that such an analysis would give programs and the School significant congruents along which they could review their structure and focus.
4. Diamond Oberoi spoke of the English Program where a research methodology course was compulsory for all students, though the writing of a dissertation was not.
5. The challenge posed to students by the demands of a pedagogy largely transacted in English was raised by faculty. This issue was further complicated by students' desire to write their assignments in English despite their relative lack of fluency in the language. Milind Wakankar referred to developments in the School of Languages including new courses which were directed towards developing and disseminating the critical vocabularies available in Hindi. Santosh Sadananandan suggested that the School experiment with translation projects from the various regional languages of critical texts that were context specific. These projects might even serve as a component of the dissertation, or the dissertation itself. Such projects could also possibly be supported by grants from the University.



6. The Visual Art program's presentation made by Shefalee Jain mentioned that the Program was initiating a process of internal review in order to see what aspects of the Program worked and what didn't. She expressed some concern about the fact that a significant part of the Program's curriculum, critical approaches to the history of technology in the visual arts, did not seem to be reflected in the end semester, final year, visual art displays. The impact of this was felt more strongly in earlier years. Prof. Hari Krishnan urged the School to explore developments in AR/VR technologies, particularly through freely available VA apps.
7. The BOS was concerned about the faculty's growing distance from their student's inner lives: 'we don't know who our learners' are' (Suchitra Balasubramanyan)
8. Akhil Katyal presented the Literary Art program in outline. This was followed by a presentation of the two courses placed before the BOS for approval.
9. The Literary Art program was asked about the incorporation of materials from across the various regional languages (Ira Bhaskar). Milind Wakankar spoke of the contrapuntal energies and the relationship between the literatures of the premodern and the modern as it is organized in the program's structure.
10. Anita Cherian mentioned that students in these courses read literary historical materials from across the languages represented in the class room with the intention being to orient students towards who they are as writers outside of the frameworks of English, Hindi, and the national.
11. Suchitra raised the issue of the setting of assignments in each course so that they would animate the curriculum. Assignments, she pointed out, should provide space for the articulation of the student's voice and subjectivity.
12. Vebhuti Duggal presented an outline of the Film Studies program and explained the restructuring that the program was undertaking through the introduction of two new core courses which would replace the ones already in place.
13. Ira Bhaskar commented on the 'misnaming' of the course called 'Facets of Indian Cinema' which from its outline seemed to be concerned with a history of Indian cinema, rather than with facets or aspects. Vebhuti explained that the BOS approved course followed a historical arc, however its focus changed depending upon the concerns of the faculty teaching it.
14. Milind Wakankar drew attention to early writing on cinema which seemed to be talking about many different things while almost inadvertently becoming the space where the emergent medium, cinema, became the focus of discussion, where it became a 'thing'. Ira Bhaskar and Vebhuti spoke of the shift in the content of writing on cinema that happened between the early decades of the 20<sup>th</sup> century and the 50s and 60s when through the writing of scholars such as

- David Bordwell and David Sklar the cultural institution of film comes to establish itself.
15. Prof. Hari Krishnan spoke of the need to introduce a course on film technology, and also the challenges of introducing such a course in a context where film technology was changing rapidly and incrementally.
  16. Ira Bhaskar urged an expansion of the scope of the program by offering more electives in areas such as digital cinema. Santosh Sadanandan suggested a rethinking of the titles of the courses most of which seemed like survey courses. Was this he asked a response to the absence of a BA level program or courses in Film Studies? Vebhuti spoke of the challenges of the curriculum, particularly those posed by a restriction of the number of core courses to 7 in the MA.
  17. Sumangala spoke of the varied challenges posed in the teaching of particular core courses, especially those taught to Performance Studies students in the 4<sup>th</sup> semester, who tended to be preoccupied with dissertation writing. She suggested that there should be no core course in the final semester, also teaching for the elective should conclude by the end of February.
  18. With reference to the School's desire to start an MA in Film Practice, Ira Bhaskar urged the school to put together all the infrastructure such an MA would require before starting the taught program. It is important to think about the students you are producing at the end of a Practice program.
  19. Faculty across SCCE expressed the hope that faculty strengths would grow so that individual programs could grow. At present all faculty on board were teaching to capacity.
  20. The BOS concluded with Deepan Sivaraman ( Chair) thanking the members of the BOS. This would be the last meeting of this group of experts.

## **II. Comments on Literary Art courses presented for approval**

1. Akhil Katyal presented his course. 'Seven Forms of Poetry'. The course was approved unanimously with Milind Wakankar suggesting that the course might even be called, 'Seven Kinds of Mood', to suggest the attunements between form and mood.
2. Suchitra Balasubramanyam suggested that Akhil add more detail about how the course develops AUD's vision. Akhil has added this information to his revision of the course.
3. A question was raised about whether the course would encourage the writing of the long poem. Akhil responded by pointing out that in the course as it is designed in the present the sestina would be the space where the long



poem was explored and attempted. Sumangala asked if the course would be able to accommodate another faculty member bringing in material from another language and teaching some part of the course. Akhil responded by saying that this possibility could be considered in the future.

4. Anita Cherian presented her course, 'Contexts and Conditions,' this course was also approved along with suggestions regarding readings and areas of investigation such as attention paid to forms of state control and intervention, and the ubiquity of the market, represented for instance by the advertising jingle. These suggestions have been incorporated into the revised draft.

Supplementary Note on the Proposal for Launch of the MA Dance Practice Programme by SCCE:  
Summary of Iterations on the Proposal in the SCAP

The MA Dance Practice Programme is proposed to be launched by the SCCE in collaboration with two partners (other than SCCE). The names of the two partners and their roles with respect to the MA Dance Practice proposal are as follows:

1. The Gati Dance Forum (TGF): A Delhi based private initiative registered in 2007 under the Indian Trust Act - with Mr. Mandeep Raikhy as the Managing Director. It is run by a collective of dance professionals, and has a focus on contemporary dance. The curriculum of the proposed MA Dance Practice programme has been largely developed by TGF.
2. The TATA Trusts: The funding partner.

Summary of iterations in the SCAP on the proposal for the launch of a MA programme in Dance Practice are as follows:

1. The SCCE organised its BoS meeting on the proposal with two members of TGF as special invitees on 11 February 2017. The programme proposal was accepted in the BoS and forwarded to the SCAP for consideration (Annexure – BoS minutes).
2. The proposal was considered by the SCAP in its meeting held on 11 April 2017. It was referred back to the BoS, SCCE, for reconsideration with notes and recommendations (Annexure – SCAP minutes).
3. The SCCE organised second meeting of its BoS on the proposal with two members of TGF as special invitees on 23 April 2017. The programme proposal was forwarded to SCAP again for consideration (Annexure – BoS minutes).
4. In its meeting held on 16 May 2017, the SCAP constituted a sub-committee to discuss the recommendations of the BoS of the SCCE. The sub-committee was formally notified on 22 May 2017 (Annexure – Notification). The Terms of Reference for the sub-committee were to review: a) Nomenclature of the programme; b) Additional seats proposed for outside NCT applicants in addition to AUD admissions policy; c) Principles and criteria for collaborations and partnerships with other institutions (Annexure – SCAP minutes)
5. The SCAP sub-committee met on 7 June and 14 June 2017, and submitted its report to the SCAP (Annexure – Sub-committee report) for discussion.
6. In its meeting convened on 22 June and 27 June 2017 the proposal for the launch of the programme was discussed at length in the light of the SCAP sub-committee report. The proceedings were documented in a detailed report (Annexure – SCAP meeting Report) and the minutes of the decisions on the matter (Annexure – Minutes of the SCAP). It was decided that the proposed MA Dance Practice programme curriculum be referred to 3 external experts for review on the academic aspects. Such non-partisan review will help in transparency in procedures as a part of the project grant is for curriculum development.
7. The Report from the 3 external reviewers was considered by the SCAP in its meeting held on 1 June 2017. It was decided that since the reports on the academic aspects of the programme are overall positive, the programme structure of the proposed programme with all the supporting documents be forwarded for consideration to the Academic Council.

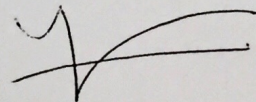

The Chairperson welcomed the gathering and presented the agenda as two fold. Considering the new MA Dance Practice program and course proposals for approval and considering the courses of existing MA programs for ratification of earlier approval by the previous meetings of board of studies so as to be presented to SCAP/AC of AUD.

Sri. Mandeep Raikhy of Gati Dance Forum, which has developed the program and courses of MA Dance Practice in collaboration with several experts in the field and the faculty of SCCE presented the program and courses. It was explained that the program structure helps students to plough the field of dance during the first year and prepare them to make a creative exploration in the second year.

The members discussed the distribution of courses as core and elective. It was felt that the students may be encouraged to take at least two electives included in the program given the relevance of the courses to the program. Members also suggested "Dance Histories" course, proposed as an elective should be offered as a core course.

The relevance of the foundation courses of SCCE in contemporary critical theory to such a practice based program was discussed. The possibility of developing two sets of foundation courses, one for theory based programs and another for practice based programs was mooted. It was agreed that in future, with the increase in student and faculty strength, this bifurcation could be designed and implemented. This will help the practice based programs to stay focused on practice with a suitable component of theoretical reflection.





The goal of the program was discussed. The question was whether the students are supposed to become practitioners or researchers after the completion of the program. While it was for individual students to make the decision, the program will envisage both possibilities and also the possibilities of using dance in education and so on.

It was suggested to streamline the evaluation pattern across courses. It was decided that it would uniformly be 30% for in class participation which would naturally include attendance, 30% for a mid term exercise and 40% for a term end production of creative or/and critical work as the case may be.

It was also suggested to update and fine tune the reading lists across the courses. Several suggestions in this regard were noted. It was also suggested to introduce a module on sound in practice courses; it was noted that as the list of visiting faculty for practice based courses is open ended there is an in built flexibility to introduce such elements.

It was decided to request Dr. Anita Cherian to be the program coordinator, with her expertise in dance writing.

With these suggestions the board passed the MA Dance Practice program and the courses as listed in Annexure I.

Dr. Rajan Krishnan presented the MA Film Studies courses. The earlier approval of the courses as presented were ratified by the members of the board. There were many suggestions for a future revision. It was felt that a special colloquium on film studies with the participation of JNU and Jadavpur University film studies faculty to brainstorm the broad directions and components of the discipline may be organized. The list of courses may be found in Annexure - II.

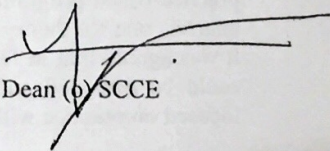

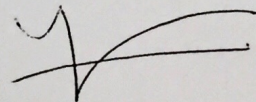

The Chairperson welcomed the gathering and presented the agenda as two fold. Considering the new MA Dance Practice program and course proposals for approval and considering the courses of existing MA programs for ratification of earlier approval by the previous meetings of board of studies so as to be presented to SCAP/AC of AUD.

Sri. Mandeep Raikhy of Gati Dance Forum, which has developed the program and courses of MA Dance Practice in collaboration with several experts in the field and the faculty of SCCE presented the program and courses. It was explained that the program structure helps students to plough the field of dance during the first year and prepare them to make a creative exploration in the second year.

The members discussed the distribution of courses as core and elective. It was felt that the students may be encouraged to take at least two electives included in the program given the relevance of the courses to the program. Members also suggested "Dance Histories" course, proposed as an elective should be offered as a core course.

The relevance of the foundation courses of SCCE in contemporary critical theory to such a practice based program was discussed. The possibility of developing two sets of foundation courses, one for theory based programs and another for practice based programs was mooted. It was agreed that in future, with the increase in student and faculty strength, this bifurcation could be designed and implemented. This will help the practice based programs to stay focused on practice with a suitable component of theoretical reflection.





The goal of the program was discussed. The question was whether the students are supposed to become practitioners or researchers after the completion of the program. While it was for individual students to make the decision, the program will envisage both possibilities and also the possibilities of using dance in education and so on.

It was suggested to streamline the evaluation pattern across courses. It was decided that it would uniformly be 30% for in class participation which would naturally include attendance, 30% for a mid term exercise and 40% for a term end production of creative or/and critical work as the case may be.

It was also suggested to update and fine tune the reading lists across the courses. Several suggestions in this regard were noted. It was also suggested to introduce a module on sound in practice courses; it was noted that as the list of visiting faculty for practice based courses is open ended there is an in built flexibility to introduce such elements.

It was decided to request Dr. Anita Cherian to be the program coordinator, with her expertise in dance writing.

With these suggestions the board passed the MA Dance Practice program and the courses as listed in Annexure I.

Dr. Rajan Krishnan presented the MA Film Studies courses. The earlier approval of the courses as presented were ratified by the members of the board. There were many suggestions for a future revision. It was felt that a special colloquium on film studies with the participation of JNU and Jadavpur University film studies faculty to brainstorm the broad directions and components of the discipline may be organized. The list of courses may be found in Annexure - II.

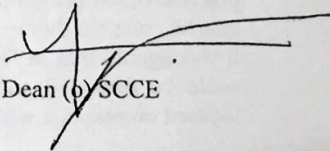

Shri B. Mallesha, Assistant Registrar (VCO & Governance) assisted the meeting.

At the outset, the Vice Chancellor (VC) extended a warm welcome to the Members of the AC and the Special Invitees. He welcomed Dr Sunita Singh, Dean (Offg.), School of Education Studies (SES) as a new member of the Council.

The following **resolutions** were passed:

**15.1 Confirmation of the minutes of the 14<sup>th</sup> meeting of the AC held on 05.12.2017**

The Council **resolved** to confirm the minutes of the 14<sup>th</sup> meeting of the AC held on 05.12.2017, as circulated on 09.02.2018.

**15.2 Action Taken Report (ATR) on the minutes of the 14<sup>th</sup> meeting of the Academic Council held on 05.12.2017**

The Council **resolved** to note the Action Taken Report (ATR) on the decisions taken in its 14<sup>th</sup> meeting held on 05.12.2017, vide **Appendix-1**.

**15.3 The recommendations of the Sub-Committee regarding the Students' Union Constitution (SUC)**

The AC in its 14<sup>th</sup> meeting held on 05 December 2017 vide its resolution no. 14.3.1, had resolved to constitute a Sub-Committee regarding the SUC with the following members: a. Professor Farida A. Khan (Government nominee on the AC) (Chair), b. Professor Sanjay Kumar Sharma (Dean, Student Services) (Convener), c. Professor Anup Kumar Dhar (Chair, ACRPM) (Member), d. Professor Lawrence Liang (Dean, SLGC) (Member); and e. Dr Rajan Krishnan (Officiating Dean, SCCE) (Member). The mandate of the Committee was to: a. draft a communication to the students informing them about the SUC and the process through which it was arrived at; b. draft a ready reckoner on the constitution for the students to be appended with the communication; c. evolve ways in which greater student participation could be elicited; and d. complete these processes by the end of January 2018. The Sub-Committee submitted its Report for the consideration of the AC, vide **Appendix-2**.

The AC noted that the draft SUC was also discussed in the 13<sup>th</sup> (vide resolution no. 13.3.1) and 14<sup>th</sup> (vide resolution no. 14.3.1) Meetings of the Council. The members of the AC appreciated the serious engagement and creative efforts of the students in drafting the SUC. The AC also took note of the observations of the Standing Committee of the Academic Council on Student Affairs (SCSA) and legal experts on the constitution submitted by students. The AC was of the opinion that future student representatives may benefit from these observations, hence they are advised and urged to take them into consideration.

After extensive deliberations on the matter, the AC **resolved** the following:

- i. The constitution of the Students' Union submitted by the elected Students' Council of 2016-17 be finalised incorporating the two directions stated below:
  - a. Article 11 (on 'Psychological Care') and Article 12 ('Research Institute for Reservations') be removed as these are outside the purview of the SUC and the ambit of the Student Council.
  - b. All provisions of the SUC in their current and future versions should comply with the prevailing general laws and the Constitution of the country, be in compliance with recommendations of the Lyngdoh Committee as per the order dated the 22<sup>nd</sup> of September, 2006 of the Supreme Court of India (vide **Appendix-3**) and in conformity with all relevant and appropriate regulatory/legal/policy frameworks related to student representation applicable from time to time.
- ii. All future amendments in the SUC proposed through due process be placed before the appropriate statutory bodies of the University for approval.

The AC **directed** the Student Services Division to finalise the SUC incorporating the aforesaid directions of the AC and the same be placed before the appropriate statutory bodies of the University for approval.

#### 15.4 The report of the Committee in the case of Shri Akunth, a student of BA (SSH), SUS, to identify the lapses on the part of the system

The AC in its 12<sup>th</sup> meeting held on 11.10.2017, vide its resolution no. 12.8.1 (concerning the case of Shri Akunth, second year student of BA (SSH), SUS), had "**resolved** to constitute a committee comprising the following members to identify the lapses on the part of the teachers and other constituents of the system and recommend appropriate actions to be initiated. Further, the committee shall come up with concrete suggestions in order to ensure an appropriate system in place to ensure non-recurrence of such lapses in future: a. Pro-Vice Chancellor-II (Chair); b. Dean, Assessment, Evaluation and Student Progression; c. Dean, Student Services; d. Dean, Academic Services; e. Dean, School of Human Studies; and f. Dean, School of Undergraduate Studies".

In pursuance of the above direction of the AC, the Committee had looked into the matter and submitted its first report to the Vice Chancellor on 10.11.2017. On receipt of this report, the Vice Chancellor made the following observations: "As Chairperson of the Academic Council, it is my sense that the report of the Committee does not measure up to the mandate given to it by the Academic Council. The Committee needs to go deeper into the systemic issues involved, look at the case in point in its full context and history, and come out with a more comprehensive report. The Committee is requested to submit its report by the 30<sup>th</sup> of November, 2017." In the context of these observations of the Vice Chancellor, the Committee had reworked on the matter and submitted its final report on 04.12.2017, vide **Appendix-4**.

The AC took note of the report and **resolved** to refer it to the Academic Services for further action after consultation with the current and former Deans of the concerned Schools.

### 15.5 The report of the Committee to Streamline the ERP System to avoid the problems related to grades, attendance records etc. of the students

In pursuance of the decision of the 12<sup>th</sup> AC Meeting held on 11.10.2017 as regards the case of Shri Akunth, second year student of BA SSH, the VC had constituted a Committee to streamline the ERP system in order to avoid the problems related to grades, attendance records etc., of the students. The Committee had the following composition (notified on 21.11.2017): a. Professor Chandan Mukherjee, Director IT Services (Chairperson); b. Professor Geetha Venkataraman, Dean AES; c. Dr. Taposik Banerjee, Assistant Professor SLS; d. Shri Harsh Kapoor, Assistant Registrar AES.

The AC **resolved** to accept the recommendations of the Committee and directed the AES Division and IT Services to take necessary actions as recommended by the Committee, vide **Appendix-5**.

### 15.6 The draft Concept Note on the Centre for Engaged Spiritualities and Peace Building (CESPB)

After deliberations on the Concept Note (**Appendix-6**) on the Centre for Engaged Spiritualities and Peace Building (CESPB), the AC directed the following:

- i. Since 'peace building' is subsumed in the conception of 'spirituality' (and also because the Centre proposes to mainly focus on spirituality) the name of the Centre should be changed to 'Centre for Engaged Spiritualities'.
- ii. While the Centre proposes to function with minimal organisational funding, the minimal budget heads required from the University should be built in the note. The organisational structure and the advisory committee for the Centre also need to be conceptualised in due course.
- iii. In addition to the activities proposed in the concept note, the AC suggested that as the Centre evolves, it could consider working in the following directions:
  - a. Identify and list the courses, already on offer across the Schools at AUD, that relate to the Centre's vision and organise them to offer certificate programmes;
  - b. Conceptualise short courses/engagements for the current students to enable them to work with conflict affected communities;
  - c. Contribute to the conceptualisation of capstone courses/programme at the undergraduate level; and
  - d. Contribute suitably to the continuing professional development of faculty and non-teaching staff.

The AC **resolved** to recommend the setting up of the Centre for Engaged Spiritualities (CES) for the consideration of the Board of Management.

### 15.7 The Concept Note on Philosophy at AUD

The AC **resolved** to in-principle approve the note (**Appendix-7**) on Philosophy at AUD with the following directions:







- i. The note should consider expanding its scope to include a wider range of philosophical perspectives/traditions (including Indian and indigenous systems of thought)
- ii. The note should be further elaborated to explain the nature of activities that will be pursued
- iii. Attempts should be made to integrate the already existing/interests in Philosophy across the Schools
- iv. The possibility of offering taught courses should not be ruled out and may be considered at a later stage.

### **15.8 The draft rules for student promotion and progression for on-the-job training component in the BVoc programmes**

The AC **resolved** to approve the progression rules for on-the-job training (OJT) component in the BVoc programmes of the School of Vocational Studies (SVS) with the **direction** that the complete Student Progression and Promotion Policy for the BVoc programmes be presented in the subsequent meetings of the AC after due approvals at various levels. It was recommended that the School should consider increasing the minimum passing grade in the OJT component from C Plus to B Minus – the AUD assessment policy provisions allow for this in the case of field and dissertation components. The revised note with progression rules for the OJT component of BVoc Programmes is at **Appendix-8**.

### **15.9 Recommendations of the Standing Committee on Academic Programmes (SCAP)**

The AC took note of the minutes (**Appendix-9**) of the meetings of the SCAP held on 29.12.2017 and 30.01.2018 **resolved** the following:

#### **15.9.1 The course outlines of 3 elective courses to be offered in the MA History programme and 3 elective courses to be offered in the MA Economics programme of the School of Liberal Studies (SLS):**

The following courses of the MA History and MA Economics programmes of SLS were presented (**Appendix-10**) in the AC meeting:

- i. MA History: 3 elective courses of 4 Credits each
  - a. Hunger, Disease and Welfare, India: 1750s-1950s (4 Credits, Elective)
  - b. Society and Culture in Early Modern Europe (4 Credits, Elective)
  - c. Partitions in South Asia (4 Credits, Elective)
- ii. MA Economics: 3 elective courses of 4 credits each
  - a. Networks: Theory and Applications (4 Credits, Elective)
  - b. Labour and Development (4 Credits, Elective)
  - c. Environmental Economics (4 Credits, Elective)

The AC **resolved** to approve the above courses with the following directions:

- i. The reading lists of the courses (especially Hunger, Disease and Welfare, India: 1750s-1950s) be organized in essential and supplementary readings

- ii. The updated MA Economics elective courses be presented in the most recent SCAP format for courses.
- iii. The overlap between the contents of the MA Economics electives (especially 'Labour and Development' and 'Environmental Economics') and courses on similar themes on offer in SDS and SHE be mapped. Based on this mapping, the possibility of co-teaching parts of the courses be explored. Such mapping of similar courses should be a general practice adopted at the School level before proposing a new course.

**15.9.2 The course outline of the elective, Multilingual Education in the Indian Context, to be offered in the MA Education and MA Education (ECCE) programmes of the School of Education Studies (SES):**

After due deliberations, the AC **resolved** to approve the course outline of the course Multilingual Education in the Indian Context (4 Credits, Elective) (**Appendix-11**) with the following directions:

- i. Since the course is on offer in the MA Education programmes, its focus should be on the practice-based aspects of multilingual teaching-learning contexts and thus a practicum component should be included in the course.
- ii. Since transition from home language to school language is a major concern in the Indian context, it should be one of the focal areas to be dealt with in the course.

**15.9.3 The reallocation of 1 credit from the field attachment component to the Introductory Statistics in Education workshop in the MA Education (ECCE) programme of SES**

The AC **resolved** to approve the reallocation of 1 credit from the field attachment component to the Introductory Statistics in Education workshop in the MA Education (ECCE) programme of SES. The workshop has already been approved in the MA Education programme in 2013 (**Appendix-12**).

**15.9.4 The course outlines of 4 elective courses to be offered in the various programmes of the School of Culture and Creative Expressions (SCCE):**

The AC **resolved** to approve the outlines of the following electives to be offered in the SCCE (**Appendix-13**) as per the following details:

- i. Crafting Poem (4 Credits, Elective), MA Literary Art programme
- ii. Media Objects/Media Theory (4 Credits, Elective), MA Film Studies programme
- iii. Musical Theatre (4 Credits, Elective), MA Performance Studies programme
- iv. Art and Public Response: Censorship, Dissent, Protest and Resistance in Contemporary Art (4 Credits, Elective), MA Visual Art programme

**15.9.5 The course outlines of 6 courses to be offered in the MA Law, Politics and Society programme of the School of Law, Governance and Citizenship (SLGC):**

The Sixth Annual Convocation of Ambedkar University Delhi for conferment of degrees/ diplomas to the students who had successfully completed all the assessment requirements of courses in the year 2017 was held on the 8th of December, 2017, at the Kashmere Gate Campus of AUD. The Chief Guest, Shri Sonam Wangchuk, delivered the Convocation Address. **15.12 Take cognizance of the amendments in the various UGC Regulations regarding recruitment and career advancement of the faculty**

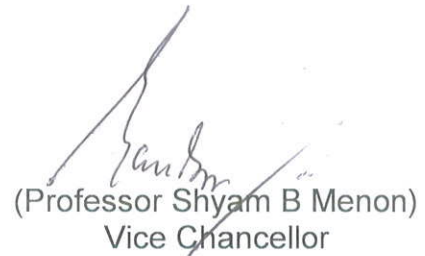

In the context of (iii) above it was suggested that in future while designing courses that are offered exclusively to programmes outside a School, allocation of teaching time be carefully considered.

Also, **resolved** to approve the following changes in the MA in Environment and Development programme structure: (i) shift of the core course “Environmental and Ecological Economics” to Semester 2 of the programme;



(ii) the revision of the name of the course "Ecological Statistics 2" to "Ecological Statistics".

#### 10.6. Other Items:

##### 10.6.1 Draft Scheme of Seed Money Grant for Faculty Research (SMGFR) as recommended by the Advisory Committee on Research and Project Management (ACRPM)

**Resolved** to approve the draft scheme of one-time Seed Money Grant for Faculty Research (SMGFR) for up to an amount of Rs.1,00,000/- as recommended by the ACRPM in its meeting held on 06.04.2017 with the following changes/modifications:

- (i) Incorporation of a brief outline of the peer review of the output of the faculty research and the necessity of submission of a written report on completion of the grant for the purposes of recording.
- (ii) While the SMGFR is a one-time grant, the output of the research that is found to be of good quality may be encouraged by some other provisions like consideration for further award of grant under some other appropriate scheme.
- (iii) Revision in the details mentioned under the provision pertaining to the use of the Seed Money Grant (item h of the draft Scheme document). The provision should be stated generically. The details of how the grant is proposed to be used should be included in the proposals submitted by faculty members applying for the grant.

The revised scheme with the recommendations suggested by the Academic council is in **Appendix-12**.

##### 10.6.2 Adoption of Policy regarding Teacher-Student Ratio for UG/PG courses of AUD as per the UGC/MHRD guidelines

The Council considered the proposal regarding the 'Adoption of a policy regarding Teacher-Student Ratio for various UG/PG programmes in AUD'. AUD's aim is to provide equitable access along with the pursuit of excellence. The quest for excellence in its initial phase has manifested itself in the nature





of programmes that were established, in faculty recruitment, the very favourable teacher-student ratio, and the attempt to institutionalise progressive curricular and assessment structures and processes. As a university focused on teaching and research in social sciences and humanities, with an emphasis on inter-disciplinarity and praxis-based teaching-learning, AUD has to maintain a small cohort size to facilitate adoption of innovative pedagogies. To sustain the pedagogies adopted by the various programmes in the University, a healthy teacher-student ratio has to be maintained. With the phenomenal growth of the University and its spreading out in multiple campuses, it is imperative to maintain the same standards that have helped AUD in achieving its current recognition in the short period of its existence.

The Council also noted that while the University Grants Commission (UGC) has prescribed norms for Teacher-Student ratio for UG and PG level from time to time, these norms should be looked at as the minimum standards to be maintained by all higher education institutions. These norms should not be used as a benchmark for universities, especially for those that aim to provide quality education comparable to the best in the world. It further noted that high quality research should remain an important objective of the University if it has to remain relevant in a highly competitive world of higher education. It also noted that the current thinking and policies on higher education at the national level are cognizant of the need to take Indian universities closer to global standards, and one of the most important factors in this is to maintain a healthy student-teacher ratio.

After detailed deliberations, the Council **resolved** to maintain a uniform teacher-student ratio of 1:15 at the University level which is in consonance with the accepted contemporary wisdom in Indian Higher Education, and the requirements of the University.

Even the professional programmes like MBA and those in Publishing and Social Entrepreneurship have so far been processed by SCAP. However, there are a number of new professional, vocational and continuing education programmes that the University is likely to launch in the near future. For instance, the newly created School of Vocational Studies (SVS) would be offering a Bachelor of Vocation (BVoc) programme with effect from the academic session 2017-18. The professional, vocational and continuing education programmes are distinct in nature from the academic programmes offered by the University through its various Schools. Therefore, there is a need for a separate Standing Committee to examine proposals from the various Schools for Professional, Vocational and Continuing Education Programmes, and





make appropriate recommendations from time to time for the consideration of the Academic Council.

After due deliberation, the Academic Council **resolved** to approve the constitution of a Standing Committee on Professional, Vocational and Continuing Education Programmes (SCPVCE) with the following composition:

- i) Dean, School of Design
- ii) Dean, School of Human Studies
- iii) Dean, School of Business, Public Policy & Social Entrepreneurship
- iv) Dean, School of Education Studies
- v) Dean, School of Vocational Studies
- vi) Dean, School of Law, Governance and Citizenship
- vii) Director, Centre for Social Science Research Methods
- viii) Director, Centre for Early Childhood Education and Development
- ix) Director, Centre for Psychotherapy and Clinical Research
- x) Director, Centre for Development Practice
- xi) Director, Centre for English Language Education
- xii) Director, Centre for Publishing
- xiii) Director, AUD Centre for Incubation, Innovation & Entrepreneurship

Professor Jatin Bhatt shall be the Chairperson of this Standing Committee till further orders.

The Standing Committee would deliberate on all matters related to professional, vocational and continuing education programmes and make recommendations from time to time for the consideration of the Academic Council.

#### **10.12.2 Exploring assessment reforms and reviewing assessment practices as a part of decennial review of AUD activities:**

At the outset, the Vice Chancellor (VC) extended a warm welcome to the Members of the AC and the Special Invitees. He welcomed Dr Sunita Singh, Dean (Offg.), School of Education Studies (SES) as a new member of the Council.

The following **resolutions** were passed:

**15.1 Confirmation of the minutes of the 14<sup>th</sup> meeting of the AC held on 05.12.2017**

The Council **resolved** to confirm the minutes of the 14<sup>th</sup> meeting of the AC held on 05.12.2017, as circulated on 09.02.2018.

**15.2 Action Taken Report (ATR) on the minutes of the 14<sup>th</sup> meeting of the Academic Council held on 05.12.2017**

The Council **resolved** to note the Action Taken Report (ATR) on the decisions taken in its 14<sup>th</sup> meeting held on 05.12.2017, vide **Appendix-1**.

**15.3 The recommendations of the Sub-Committee regarding the Students' Union Constitution (SUC)**

The AC in its 14<sup>th</sup> meeting held on 05 December 2017 vide its resolution no. 14.3.1, had resolved to constitute a Sub-Committee regarding the SUC with the following members: a. Professor Farida A. Khan (Government nominee on the AC) (Chair), b. Professor Sanjay Kumar Sharma (Dean, Student Services) (Convener), c. Professor Anup Kumar Dhar (Chair, ACRPM) (Member), d. Professor Lawrence Liang (Dean, SLGC) (Member); and e. Dr Rajan Krishnan (Officiating Dean, SCCE) (Member). The mandate of the Committee was to: a. draft a communication to the students informing them about the SUC and the process through which it was arrived at; b. draft a ready reckoner on the constitution for the students to be appended with the communication; c. evolve ways in which greater student participation could be elicited; and d. complete these processes by the end of January 2018. The Sub-Committee submitted its Report for the consideration of the AC, vide **Appendix-2**.

The AC noted that the draft SUC was also discussed in the 13<sup>th</sup> (vide resolution no. 13.3.1) and 14<sup>th</sup> (vide resolution no. 14.3.1) Meetings of the Council. The members of the AC appreciated the serious engagement and creative efforts of the students in drafting the SUC. The AC also took note of the observations of the Standing Committee of the Academic Council on Student Affairs (SCSA) and legal experts on the constitution submitted by students. The AC was of the opinion that future student representatives may benefit from these observations, hence they are advised and urged to take them into consideration.

After extensive deliberations on the matter, the AC **resolved** the following:

- i. The constitution of the Students' Union submitted by the elected Students' Council of 2016-17 be finalised incorporating the two directions stated below:
  - a. Article 11 (on 'Psychological Care') and Article 12 ('Research Institute for Reservations') be removed as these are outside the purview of the SUC and the ambit of the Student Council.
  - b. All provisions of the SUC in their current and future versions should comply with the prevailing general laws and the Constitution of the country, be in compliance with recommendations of the Lyngdoh Committee as per the order dated the 22<sup>nd</sup> of September, 2006 of the Supreme Court of India (vide **Appendix-3**) and in conformity with all relevant and appropriate regulatory/legal/policy frameworks related to student representation applicable from time to time.
- ii. All future amendments in the SUC proposed through due process be placed before the appropriate statutory bodies of the University for approval.

The AC **directed** the Student Services Division to finalise the SUC incorporating the aforesaid directions of the AC and the same be placed before the appropriate statutory bodies of the University for approval.

#### 15.4 The report of the Committee in the case of Shri Akunth, a student of BA (SSH), SUS, to identify the lapses on the part of the system

The AC in its 12<sup>th</sup> meeting held on 11.10.2017, vide its resolution no. 12.8.1 (concerning the case of Shri Akunth, second year student of BA (SSH), SUS), had "**resolved** to constitute a committee comprising the following members to identify the lapses on the part of the teachers and other constituents of the system and recommend appropriate actions to be initiated. Further, the committee shall come up with concrete suggestions in order to ensure an appropriate system in place to ensure non-recurrence of such lapses in future: a. Pro-Vice Chancellor-II (Chair); b. Dean, Assessment, Evaluation and Student Progression; c. Dean, Student Services; d. Dean, Academic Services; e. Dean, School of Human Studies; and f. Dean, School of Undergraduate Studies".

In pursuance of the above direction of the AC, the Committee had looked into the matter and submitted its first report to the Vice Chancellor on 10.11.2017. On receipt of this report, the Vice Chancellor made the following observations: "As Chairperson of the Academic Council, it is my sense that the report of the Committee does not measure up to the mandate given to it by the Academic Council. The Committee needs to go deeper into the systemic issues involved, look at the case in point in its full context and history, and come out with a more comprehensive report. The Committee is requested to submit its report by the 30<sup>th</sup> of November, 2017." In the context of these observations of the Vice Chancellor, the Committee had reworked on the matter and submitted its final report on 04.12.2017, vide **Appendix-4**.

The AC took note of the report and **resolved** to refer it to the Academic Services for further action after consultation with the current and former Deans of the concerned Schools.

### 15.5 The report of the Committee to Streamline the ERP System to avoid the problems related to grades, attendance records etc. of the students

In pursuance of the decision of the 12<sup>th</sup> AC Meeting held on 11.10.2017 as regards the case of Shri Akunth, second year student of BA SSH, the VC had constituted a Committee to streamline the ERP system in order to avoid the problems related to grades, attendance records etc., of the students. The Committee had the following composition (notified on 21.11.2017): a. Professor Chandan Mukherjee, Director IT Services (Chairperson); b. Professor Geetha Venkataraman, Dean AES; c. Dr. Taposik Banerjee, Assistant Professor SLS; d. Shri Harsh Kapoor, Assistant Registrar AES.

The AC **resolved** to accept the recommendations of the Committee and directed the AES Division and IT Services to take necessary actions as recommended by the Committee, vide **Appendix-5**.

### 15.6 The draft Concept Note on the Centre for Engaged Spiritualities and Peace Building (CESPB)

After deliberations on the Concept Note (**Appendix-6**) on the Centre for Engaged Spiritualities and Peace Building (CESPB), the AC directed the following:

- i. Since 'peace building' is subsumed in the conception of 'spirituality' (and also because the Centre proposes to mainly focus on spirituality) the name of the Centre should be changed to 'Centre for Engaged Spiritualities'.
- ii. While the Centre proposes to function with minimal organisational funding, the minimal budget heads required from the University should be built in the note. The organisational structure and the advisory committee for the Centre also need to be conceptualised in due course.
- iii. In addition to the activities proposed in the concept note, the AC suggested that as the Centre evolves, it could consider working in the following directions:
  - a. Identify and list the courses, already on offer across the Schools at AUD, that relate to the Centre's vision and organise them to offer certificate programmes;
  - b. Conceptualise short courses/engagements for the current students to enable them to work with conflict affected communities;
  - c. Contribute to the conceptualisation of capstone courses/programme at the undergraduate level; and
  - d. Contribute suitably to the continuing professional development of faculty and non-teaching staff.

The AC **resolved** to recommend the setting up of the Centre for Engaged Spiritualities (CES) for the consideration of the Board of Management.

### 15.7 The Concept Note on Philosophy at AUD

The AC **resolved** to in-principle approve the note (**Appendix-7**) on Philosophy at AUD with the following directions:







- i. The note should consider expanding its scope to include a wider range of philosophical perspectives/traditions (including Indian and indigenous systems of thought)
- ii. The note should be further elaborated to explain the nature of activities that will be pursued
- iii. Attempts should be made to integrate the already existing/interests in Philosophy across the Schools
- iv. The possibility of offering taught courses should not be ruled out and may be considered at a later stage.

### **15.8 The draft rules for student promotion and progression for on-the-job training component in the BVoc programmes**

The AC **resolved** to approve the progression rules for on-the-job training (OJT) component in the BVoc programmes of the School of Vocational Studies (SVS) with the **direction** that the complete Student Progression and Promotion Policy for the BVoc programmes be presented in the subsequent meetings of the AC after due approvals at various levels. It was recommended that the School should consider increasing the minimum passing grade in the OJT component from C Plus to B Minus – the AUD assessment policy provisions allow for this in the case of field and dissertation components. ### **15.9 Recommendations of the Standing Committee on Academic Programmes (SCAP)**

The AC took note of the minutes (**Appendix-9**) of the meetings of the SCAP held on 29.12.2017 and 30.01.2018 **resolved** the following:

#### **15.9.1 The course outlines of 3 elective courses to be offered in the MA History programme and 3 elective courses to be offered in the MA Economics programme of the School of Liberal Studies (SLS):**

The following courses of the MA History and MA Economics programmes of SLS were presented (**Appendix-10**) in the AC meeting:

- i. MA History: 3 elective courses of 4 Credits each
  - a. Hunger, Disease and Welfare, India: 1750s-1950s (4 Credits, Elective)
  - b. Society and Culture in Early Modern Europe (4 Credits, Elective)
  - c. Partitions in South Asia (4 Credits, Elective)
- ii. MA Economics: 3 elective courses of 4 credits each
  - a. Networks: Theory and Applications (4 Credits, Elective)
  - b. Labour and Development (4 Credits, Elective)
  - c. Environmental Economics (4 Credits, Elective)

The AC **resolved** to approve the above courses with the following directions:

- i. The reading lists of the courses (especially Hunger, Disease and Welfare, India: 1750s-1950s) be organized in essential and supplementary readings

- ii. The updated MA Economics elective courses be presented in the most recent SCAP format for courses.
- iii. The overlap between the contents of the MA Economics electives (especially 'Labour and Development' and 'Environmental Economics') and courses on similar themes on offer in SDS and SHE be mapped. Based on this mapping, the possibility of co-teaching parts of the courses be explored. Such mapping of similar courses should be a general practice adopted at the School level before proposing a new course.

**15.9.2 The course outline of the elective, Multilingual Education in the Indian Context, to be offered in the MA Education and MA Education (ECCE) programmes of the School of Education Studies (SES):**

After due deliberations, the AC **resolved** to approve the course outline of the course Multilingual Education in the Indian Context (4 Credits, Elective) (**Appendix-11**) with the following directions:

- i. Since the course is on offer in the MA Education programmes, its focus should be on the practice-based aspects of multilingual teaching-learning contexts and thus a practicum component should be included in the course.
- ii. Since transition from home language to school language is a major concern in the Indian context, it should be one of the focal areas to be dealt with in the course.

**15.9.3 The reallocation of 1 credit from the field attachment component to the Introductory Statistics in Education workshop in the MA Education (ECCE) programme of SES**

The AC **resolved** to approve the reallocation of 1 credit from the field attachment component to the Introductory Statistics in Education workshop in the MA Education (ECCE) programme of SES. The workshop has already been approved in the MA Education programme in 2013 (**Appendix-12**).

**15.9.4 The course outlines of 4 elective courses to be offered in the various programmes of the School of Culture and Creative Expressions (SCCE):**

- iv. Art and Public Response: Censorship, Dissent, Protest and Resistance in Contemporary Art (4 Credits, Elective), MA Visual Art programme

**15.11 The AC noted the report on the Sixth Annual Convocation held on the 8<sup>th</sup> of December, 2017 as per the following details:**

The Sixth Annual Convocation of Ambedkar University Delhi for conferment of degrees/ diplomas to the students who had successfully completed all the assessment requirements of courses in the year 2017 was held on the 8th of December, 2017, at the Kashmere Gate Campus of AUD. The Chief Guest, Shri Sonam Wangchuk, delivered the Convocation Address. The Hon'ble Lt Governor of Delhi, Shri Anil Baijal, in his capacity as the Chancellor of the University presided over the Convocation ceremony.

568 students who completed the prescribed requirements during the academic year 2016-17 were awarded with PhD, MPhil, MBA, MA, BA (Hons) Degrees in various fields of studies. Post Graduate Diplomas in Development Studies, Early Childhood Care & Education and Environment & Development were also awarded.

The composition of the students who received their degrees and diplomas is as follows: BA (Hons): 161, MA: 342, MBA: 38, MPhil: 13, PhD: 7, PG Diploma: 7. **15.12 Take cognizance of the amendments in the various UGC Regulations regarding recruitment and career advancement of the faculty**

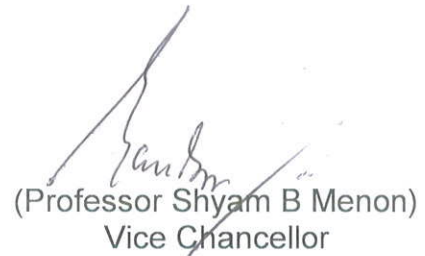

The AC authorised the VC to expand the advisory committee of the Academic Services for the purpose of a thorough examination of the faculty recruitment and Career Advancement Policy of AUD in the light of these developments.

#### MINUTES OF THE NINTH BOARD OF STUDIES MEETING HELD ON 5<sup>th</sup> December, 2018

Prof. Ira Bhaskar and Prof. Sumangala Damodaran could not attend the meeting.

The Chair welcomed the members of the board, briefed them about the developments related to the school and the university in the opening remarks, following which three new courses were taken up for discussion. It was also resolved that in future the notice issued for the Board of Studies meeting at least ten days before should be accompanied by the agenda items and the courses to be discussed in the prescribed proforma so that members can read and reflect on the courses beforehand.

It was reported that the two core courses taught in MA Film Studies program, Psyche and Screen and Images and Signs and Cinema in the second and third semester respectively are sought to be made elective courses, following suggestions from the BOS members in the previous meetings and on the basis of feedback from students. These two courses, while being focussed and rigorous are seen to be of highly demanding nature in terms of the difficulty of the texts, for half the number of students at least. Hence making them electives would allow students who are keen on taking up such intense theoretical courses to pursue them, while allowing other students to seek a more general orientation to theoretical literature in film studies. With that intent two new core courses were presented which would replace these courses.

In continuation of the Evolution of Cinema as Art-I offered in the first semester where students study the evolution of the film narrative from the birth of cinema, through early short films, evolution of film narration, Griffith and Soviet Montage, German Expressionism, Phalke in India and so on, a follow up course named Evolution of Cinema as Art II will be introduced in the second semester to acquaint students with the variety of experiments in film narrations that took place around the world through a sampling of key film texts, movements and auteur. The course was discussed by the members of studies who made a few suggestions on accommodation of which the course may be taken as passed. The following are the suggestions:



1. The course need not look like a survey of national cinemas or take geographical divisions as in area studies as the matrix. It will be better to take key film texts, movements and auteur for their contribution to the evolution of and experimentation in film narration. Since no comprehensive survey is possible the selection needs to focus on the critical yield for thinking on cinema.
2. It will help if the course is **structured** through key film texts rather than theoretical readings accompanying them. Hence all films that would be screened need to be named with a brief note on the basis of selection.
3. It is best to plan for 12 weeks as full 14 weeks may not become possible due to holidays and other contingent events in campus and the city. The two weeks are to be kept as buffer time.

The second film studies course bearing title “Introduction to Film Theory” was taken up for discussion. The course was passed with the condition that the following suggestions be considered and suitably incorporated.

1. The survey of film theory need not be taken as comprehensive ; the texts given as essential readings can be less in number. The possibility of combining two or three modules into one may be considered. For example a given theoretical text may combine feminist, psychoanalytic and semiotic approaches which if closely read and discussed can help students to understand these in a given context. There can be long list of texts in suggested readings but essential readings need to be as few as possible to allow for thorough reading and absorption by all students.
2. The effective teaching weeks may be taken as 12 to compensate for cancellation of classes due to contingent reasons and holidays.
3. Film screenings may not be done during the two plus two hours of teaching each week since the theoretical texts need to be parsed and discussed for the benefit of the students. These may be scheduled separately if it has to be collective viewing. The primary intent of this course is best taken as capacity building to read and comprehend texts of film theory.

An elective course proposed for MA Literary Art program bearing the title “Contemporary South Asian Poetry in English and English Translation” was taken up for consideration. After elaborate discussion the board of studies requested the program to rework the course and present it in the next meeting taking following issues into consideration.

1. It may be considered whether the area studies category “South Asia” is necessary for the purposes of the course. Once the phrase “Contemporary South Asia” is coined, it is hard not to be a survey course with representative samples from different constituencies.
2. The choice of the poets to be studied, four in the present format, needs to be substantiated in order to avoid appearing arbitrary. It is felt by members that the contradiction between the members of the pair “Faiz Ahmed Faiz and Agha Shahid Ali” and the pair “Meena Kandasamy and Tishani Joshi” calls for greater explanation in terms of selection. It may be more useful even to stay with one pair that provides greater coherence and opportunities for critical absorption.

A brief review in the mode of a free wheeling conversation of some of the programs including the pilot program MA Performance Practice (Dance) , during which it was suggested to strive for greater collaboration among different programs in overlapping areas of interest, concluded the meeting.
